



## Hire Agreement for Lawn Games and Letters

This Hire Agreement ("Agreement") is made and entered into between the hirer ("Hirer") and the owner of the Lawn Games and Letters ("Owner"). The Agreement is effective as of [Agreement Date].

### 1. Lawn Games and Letters:

The Owner agrees to hire out the following lawn games and letters to the Hirer:

Any disputes arising out of or in connection with this Agreement shall be resolved through amicable negotiations. If a resolution cannot be reached, the parties agree to submit to mediation by a third party at their own expense.



9. Entire Agreement:

This Agreement constitutes the entire understanding between the Hirer and the Owner regarding the hire of the lawn games and letters and supersedes all prior agreements, understandings, or representations, whether oral or written.
