Under the NASA NEMCON PWS 6 scope, SDZ Enterprise provided high-level strategic and administrative support to NASA Headquarters' Environmental Management Division (EMD). Services included program management across environmental domains such as NEPA, EMS, sustainability, energy, restoration, and compliance, alongside natural and cultural resource management. SDZ also led initiatives in workforce planning, SharePoint modernization, and Kaizen facilitation to optimize EMD operations. Deliverables included documentation, project tracking, and SME consultation, supported by limited travel. This performance (March–September 2024) advanced EMD's operational efficiency and environmental mission goals.
