

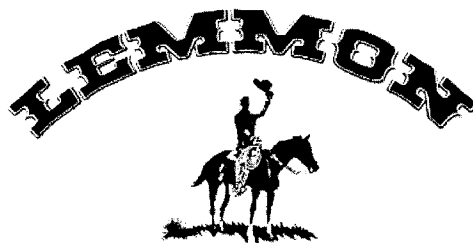

WRHS Visiting Nurse Services offering Top-Quality In-Home Care

The West River Health Services "Visiting Nurse" Team is an underrated, but dynamic part of the local healthcare system. This was so evident during Covid a few years back, when folk were nervous about coming to the hospital themselves. These nine WRHS registered nurses provide skilled, professional care in the comfort of the patient's home. Most of these nurses have been providing nursing care for 10, 20, 30 and in a few cases, over 40 years! Mari Stelter, the WRHS Visiting Nurse Manager summed up their efforts as: "our visiting nurses work closely with the patient's physician to communicate timely changes and provide consistent oversight of routine clinical assessments and safe medication management, which helps keep the patient's chronic conditions stable."

WRHS Visiting Nurses do not provide rehabilitation services like physical, occupational or speech therapy. Their home visits are usually provided weekly, but can be more often or less, depending on the individual patient's needs.

How does someone acquire WRHS Visiting Nurse Services? You need to have a physician with West River Health Services or have Veterans Administration (VA) benefits within the ND or SD VA Network system. Through traditional Medicare, the patient must be homebound and have an order from their physician for skilled services. To initiate WRHS Visiting Nurse Services, the patient can make an appointment with their WRHS provider to discuss if WRHS Visiting Nurse Services might be appropriate for them. If so, the provider would write a referral order for WRHS Visiting Nurse Services and send the order to their office.

Once the order is received at the WRHS Visiting Nurse Office, they look into your ability to pay for services. According to Stelter, "costs are billed to

the patient's insurance, usually Medicare or Medicaid and a supplemental insurance plan. The primary insurance will not cover the entire cost of services, so supplemental insurance is needed. VA or other insurances require authorizations prior to start of services to ensure that services are covered. Private pay is an option if the patient does not qualify for homebound status or are not covered by other insurances." Patients should contact the WRHS Visiting Nurse Office at 701-567-6171 to discuss the private pay option.

Where does WRHS Visiting Nurse offer their services? WRHS Visiting Nurse provides safe and dependable in-home care to patients living in south-west ND and northwest SD. Our three primary offices are based out of each WRHS Rural Health Clinic in Hettinger, Mott and Lemmon. The WRHS Visiting Nurses travel in roughly a 40 mile radius of these three towns. Currently patients are seen in six area counties: Adams, Hettinger and Grant Counties in ND; and Harding, Perkins and Corson Counties in SD. WRHS

Visiting Nurse Program currently sees about 80 patients, completing roughly 75 visits per week and approximately 300 visits per month.

The current WRHS Visiting Nurse Team consists of ten staff members, including nine registered nurses and one administrative assistant: Mari Stelter, Jeanette Dietz, Patty Ness, Stacy Drayton, Lori Pierson, Audrey Skogen, Barb Maychszak, Tina Friebe, Darlynn Bishop and Kylie Stadheim.

If you'd like to have a WRHS Visiting Nurse become part of your healthcare plan, please make an appointment with your WRHS provider at 701-567-4561. If you have any questions about the WRHS Visiting Nurse Program, you can always call their office at 701-567-6171. They both will be more than happy to set up an appointment and get the ball rolling. 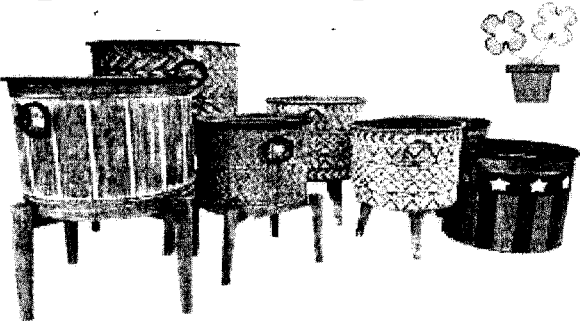

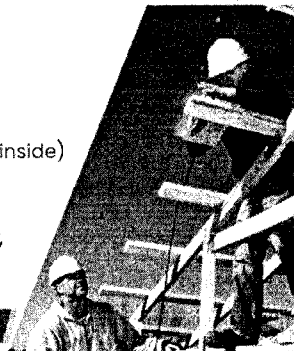

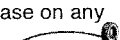

Frontier Travel Center in Bowman, North Dakota will be celebrating their 20-year anniversary in a big way. Frontier Travel Center first opened its doors on April 5th 2005 under Scranton Equity and its Board of Directors.

With overwhelming support from the community FTC has undergone many changes and upgrades over the years. Upon opening FTC was branded Sinclair for its gas and diesel fuel. At the end of a 10-year contract with Sinclair the branding changed to Exxon in 2014. As of 2025 re-branding to Top-Tier fuel has taken place. The new branding will allow FTC to shop around for the best pricing of Top-Tier fuel and pass that savings along to its customers.

The car wash was added in 2008, the tills were remodeled, the Beer Cave and Java counter added. In 2011 the area to the south of FTC was bought for truck parking and 10 cold storage units built. The east diesel island was added in 2013. Additional space was needed and in 2014 office space, a supply room and cooler added. The bathrooms were remodeled in 2017; the gas and diesel pumps were upgraded in 2019. 2020 brought an additional 5 cold storage units, new cabinets and countertops for the C-Store, Deli and Java. A natural gas generator was purchased in 2021, allowing FTC to provide service in the event the electricity is out. A reverse osmosis system was added in 2024 to provide better tasting coffee and fountain drinks to their customers. The Travel Information Booth is now located inside FTC for tourists passing through the area.

Frontier Travel Center at the crossroads of Highway 85 & 12 is now a must stop for travelers and locals looking for a needed cup of coffee, snack or restroom. Much of FTC's success can be attributed to the longevity of its management staff. While CFO, Ben Hetzel is based out of Scranton, the in-house management sees to the day-to-day operations. Becky Brooks - Assistant Manager, Wanda Heick - Purchasing Manager, Barb Bickel - Office Manager and new on-the-block, Chanell Walby - Manager in Training. The management staff have collectively over 50 years of service to FTC.

Expressions
of Hope

Reflections on the
Words of Life

by Pastor Paul Ferrie, Grace
Reformed Church of the Lord
Jesus, New Leipzig

Last week we began considering 2 Peter 2:1, which begins a section explaining how the Word of God is used to make the believer progressively more like Christ. We saw that the first area Peter mentions is conviction of sin. The Holy Spirit faithfully convicts believers of the sin in their lives. Though not enjoyable, this is a blessing and an evidence that one is truly a child of God. Let us now look at the specific sins which Peter lists in verse 1: "Therefore, laying aside all malice, all deceit, hypocrisy, envy, and all evil speaking."

The first sin mentioned is malice. This refers to a hateful attitude toward others, sometimes accompanied by intent to harm the objects of hatred. Such hatred is incompatible with being a child of God. God instructs His children to love all people, even our enemies. When a believer detects malice in his or her heart, this should be a warning that sinful flesh needs to be subdued by the power of the Holy Spirit. Furthermore, Peter says we should lay aside ALL malice. Believers will constantly need to fight against the tendency to try to get comfortable with allowing some sin to linger undealt with. Peter says not to let any malice remain. When the Spirit points it out, confess it to God and ask for His grace to get rid of it.

We take up the next two sins together because they are closely related: We are to lay aside all deceit and hypocrisy. Jeremiah describes the wickedness of fallen human nature in Jeremiah 17:9: "The heart is deceitful above all things, and desperately wicked; who can know it?" In other words, human beings are such masters at deceiving that we may try to convince ourselves that we are not

deceiving or being hypocritical. The case of Ananias and Sapphira in Acts 5 is a clear example of the connection between deceit and hypocrisy, and it cost their lives. This couple pretended to have given all proceeds from the sale of their property to the church, when they had given only part. There was nothing wrong with giving part and even with not giving any. But their deceit led them to hypocrisy. We read in Acts 5:3-5, "Peter said, 'Ananias, why has Satan filled your heart to lie to the Holy Spirit and keep back part of the price of the land for yourself? While it remained, was it not your own? And after it was sold, was it not in your own control? Why have you conceived this thing in your heart? You have not lied to men but to God.' Then Ananias, hearing these words, fell down and breathed his last." Not long afterward Sapphira was confronted by Peter: "Now it was about three hours later when his wife came in, not knowing what had happened. And Peter answered her, 'Tell me whether you sold

the land for so much?' She said, 'Yes, for so much.' Then Peter said to her, 'How is it that you have agreed together to test the Spirit of the Lord? Look, the feet of those who have buried your husband are at the door, and they will carry you out.' Then immediately she fell down at his feet and breathed her last" (Acts 5:7-10). Deceit and hypocrisy are not to be taken lightly.

Believers, let us be careful. There are constant temptations to try to portray ourselves as something we are not. Pride stirs up the desire to build ourselves up before others, and deceit and hypocrisy become the tools for doing so. How thankful we should be that we have a Savior who not only forgives our sins but also works in us to get rid of them and become more like Himself. Friends, if you have not trusted in Christ alone to make you right with God, you have no such hope. Please do not delay to have serious dealings with Him. He gladly receives all who sincerely come to Him for mercy.
