## Course Description:

This graduate-level course will explore the history of The Student Transfer Law. Emphasis will be placed on the Breitenfeld vs. School District of Clayton court decision (2013). This course will use the book "Transfers & Open Enrollment: The Denigration of Black School Communities" as a primary text to examine the short-term and long-term effects of student transfers, particularly on Black schools and communities. Students will analyze the challenges less-resourced school districts face in paying transportation and tuition costs for student transfers while also exploring Open Enrollment options for students. Through class discussions, readings, research, and other practical assignments, students will gain a deeper understanding of the complexities of educational policies and their effects on Black school communities.

## **Course Goals:**



- Understand the history and background of The Student Transfer Law
- Analyze the Breitenfeld vs. School District of Clayton decision and its impact on Black schools and communities
- Critically examine the short-term and long-term effects of student transfers on Black communities
- Evaluate the challenges faced by less resourced school districts in paying transportation and tuition costs for student transfers
- Explore the impact of Open Enrollment options on students
- Develop critical thinking and analytical skills through class discussions, readings, research, and other practical assignments

This course will consist of 16 weeks of asynchronous learning spread out between eight modules. The summer course will consist of 12 weeks of asynchronous learning spread out between six modules.

#### **GRADING**


- Course participation and engagement (20%)

## **About The Professor**

Dr. Howard E. Fields III is an award-winning leader, author, creator, and adjunct professor.

In his first year as a principal, Dr. Fields was responsible for navigating the Ferguson Unrest because his school was located down the street from where Michael Brown Jr. was shot and killed by a police officer. Though there were five months of contentious interactions between community members and law enforcement, Dr. Fields' leadership was a driving factor in increasing his school's Annual Performance Report (APR) by 200% and reading proficiency by 20%. As a result, Dr. Fields was recognized by the Missouri Association of Elementary School Principals (MAESP) as a 2016 Exemplary New Principal. That same year, he was named one of North (St. Louis) County Incorporated's 30 Leaders in their Thirties.

After nine years in urban education, Dr. Fields transitioned to a suburban school district in the fall of 2017. Within one year, Dr. Fields expanded elective course options for students to include Computer Science, Drama, Art & Design, and Foreign Language, all with existing district staff. He also implemented Passion Days, a shared facilitation model that allows students to learn from staff and community passions before sharing their passions with their classmates.

In 2020, Dr. Fields co-founded Black Males in Education St. Louis (BMESTL) and The State of Black Educators Symposium. Later that year, he was inducted into the first class of the Mehlville School District Alumni Hall of Fame while also being named the 2020 National Elementary Distinguished Principal from Missouri.

Dr. Fields is a 2023 graduate of the AASA and Howard University's Urban Superintendent Academy. In addition to serving as the Assistant Superintendent of Human Resources, Dr. Fields leverages his experience in recruiting, developing, and supporting those seeking jobs within the education field as cofounder of EduOpenings.
