The Carolina Ice Zone's Learn To Play Hockey Program will offer a chance for new players to increase their skating and hockey skills in a systematic and progressive manner. The program offers a high level of flexibility in instruction and is adjusted to teach each player based on his or her capabilities and previous experience. After participation, a player may choose to continue with the Learn To Play program to increase their skills or may be ready for the Jr. Pirate Youth Hockey League or Adult C-League.

**Prerequisite** – Participant should have passed Basic 2 or Adult 2 in the Learn to Skate Program, OR have mastered forward and backward skating and gliding and be able to stop on their own.

**Cost** – \$75 per 4 week session, or \$25 per class walk-on
