



## 2020 FALL Carolina IceZone Jr. Pirate Youth/Teen Hockey League

The Carolina IceZone Youth/Teen Hockey League offers a chance for new and experienced players to increase their skills in a positive environment that promotes good sportsmanship and having **FUN!**

Season begins approximately September 29<sup>th</sup> and runs through approximately December 17<sup>th</sup>. **All players** will have 2 on ice sessions per week (approximately 22 regular guaranteed on-ice team practices/scrimmages/games *plus approximately 4 additional Player Development Sessions for the FALL season*). Exact season schedule will be available for each team once registration and new player evaluation is complete.

### Tentative age divisions:

**U6 / U8 Mite House Program** – Practices, Scrimmages, and Games to be held on Tuesday, Thursday, and/or Saturday, plus one Home Jamboree. Occasional Sunday ice slots may also be scheduled.

**U10 / U12 / U14 House Program** – Practices, Scrimmages, and Games to be held on Tuesday, Thursday and/or Saturday. Occasional Sunday ice slots may also be scheduled.

**Junior Pirate Student Hockey League (JPSHL – older middle school and high school students)** – Practices, Scrimmages, and Games to be held on Tuesday and/or Thursday evenings and Saturday mornings. Occasional Sunday ice slots may be scheduled.

**\$395/Player + \$55/uniform fee if paid in full by September 17<sup>th</sup>, 2020 (\$25 additional fee if paid after 9/19/20 or if paying by installments)**

**\*Jersey/Sock fee of \$55 for all players includes 2 house league jerseys and a pair of game socks**

**Payment Plan Option: \$250 due by 9/17/19, \$225 due 10/15/19 (includes dues plus jersey/sock fee)**

**\*USA Hockey Membership required and confirmation number must be submitted with registration – No Exceptions!**

*-Season protocols and expectations of players and parents will be announced prior to the season and will be in line with all government mandates and recommendations. Players/parents/guardians will be expected to abide by all league rules which are not limited to but may include no spectators at events for part or all of the season, dressing at home, limited capacity on the ice, daily temperature checks, season pause or delay, only in-house scrimmaging instead of games, etc.*

*-SELECT Teams may be formed for limited travel games/tournaments if government restrictions are lifted and coaches feel that there are enough players in any one or more age divisions that would be competitive. If this happens, criteria will be made available to parents on the selection process and additional fees that may be involved for participation on a Select Travel Team.*
