



## 2019-2020 Carolina IceZone Jr. Pirate Youth/Teen Hockey League

The Carolina IceZone Youth/Teen Hockey League offers a chance for new and experienced players to increase their skills in a positive environment that promotes good sportsmanship and having FUN!

Season begins on Tuesday, October 1st and ends on Saturday, March 7<sup>th</sup>. All players will have 2 on ice sessions per week (approximately 40 regular guaranteed on-ice team practices/games) plus the addition of approximately 8 Player Development Sessions for the upcoming season (approximately every other week). Exact season schedule will be available for each team once registration and new player evaluation is complete.

Tentative age divisions for 2019-2020 (may adjust based on enrollment and player skill level):

**U8 Mite / U10 Squirt B Program** – Practices and Games to be held on Tuesday, Thursday, and/or Saturday.

**U10/ U12 Squirt A / Pee Wee Program** - Practices and Games to be held on Tuesday, Thursday and/or Saturday.

Junior Pirate Student Hockey League (JPSHL - older middle school and high school students) - Practices and Games to be held on Tuesday and/or Thursday evenings and Saturday mornings.

\$775/Player if paid in full by August 24<sup>th</sup>, 2019\* (\$25 late fee if paid after 8/24/19)

\*Jersey Fee of \$75 – new players only or returning players wanting new jerseys

Payment Plan Option: \$200 (\$275 if ordering jerseys) due by 8/24/19, \$200 due 10/15/19, \$200 due 11/15/19, \$200 due by 12/15/19
