On July 5, 2011 at 6:10 pm, SA Booth, SA Dicus and Joey Hudgens interviewed Jason Autry at his residence of 118 Bell Park Road in Holladay, Tennessee. After proper identification and explanation of the purpose, Mr. Autry voluntarily provided the following information:

I know Holly Bobo. I am kin to her through her father. Gary Autry and he are cousins and he lives at 1333 Bear Creek Road behind Tucker's Restaurant.

My friends are Zack Adams and Shayne Austin. Shayne is my first cousin. Zack has a girlfriend named Rebecca Earp. I do not think that either one of them had anything to do with her kidnapping. If I knew something on them, I would turn them in a heartbeat and buy a new truck with the money. They would do the same to me. I heard that Zack and Shayne were together when ya'll where activated.

I work for Jay Taylor. His number is (731) 847-6034. On Wednesday, April 13, 2011, I can't lock into where I was. I have to be to work at 8:00 am. I usually get up right around then and head to work. Back then, I was working with Mike Douglass. He is from Benton County and he works at DuPont. I used to work his farm on Big Sandy River Road.

I live in this house with my mother and step-father. Angela Scott is my old girlfriend that I was dating at the time. She drives a 2004 black Expedition. Her telephone number is (731) 548-1064.

I didn't go to the coon hunt this year. I don't think that Shayne or Zack went to it either. The red Ford in the driveway is mine. That is the only vehicle that I ever drive. The PT Cruiser in the driveway belongs to my mom.

I have been to prison a total of three times. I have spent time at the Turney Center and in Clifton. I have been charged with drug charges and theft and been violated several times on the drug charges.

I don't know of anyone that goes hunting down there by the Bobo's. Shayne deer hunts some. Zack goes hunting with a bow and muzzle loader. That is all that I ever hunt. None of us go turkey hunting.

I saw both Zack and Shayne two or three days ago. I went to each one of their houses separately. We talked about the Bobo case. We compared theories. I am positive that neither one of them were involved and I know that I wasn't involved.

When I go hunting, I go on my grandmother's farm on Yellow Springs Road. It is the first house
