

The minutes of the May 20, 2025 White Lake City council meeting.

Roll Call has three (3) council members present, Schroeder, Hetland, Guericke. A quorum was declared. The meeting was called to order by Mayor Kim Ehlers at 7:00 pm.

Schroeder moves that to approve the agenda. Hetland seconded the motion. Mayor declares all ayes, motion is carried.

New Business:

Council committees were assigned by Mayor Kim Ehlers. Guericke and Ehlers are on Finance, Ordinances, & Law Enforcement, Hetland and Ehlers on Daycare, Schroeder and Guericke are on Streets and Alleys, Schroeder and Guericke are on Water & Sewer, Hetland and Helers on Parks Pool and Rec, Guericke and Reeves are on buildings, Reeves and Hetland are on White Lake Community and Economic Development, and Hetland and Reeves are on Library.

Hetland motioned to appointment Schroeder as president. Guericke seconded motion. Guericke motioned to cease nominations. Hetland seconded the motion. Mayor Declares all ayes, motion is carried.

Mayor Ehlers declared Farmers and Merchants State Bank to remain the bank, The Standard to remain the paper, and Jim Taylor to remain the attorney.

Merlin Konechne came to the meeting to talk about the baseball/football fields. The school would like to talk about possibly selling the land to the city. Committee members will get together and discuss at this time.

The Finance office computer needs to be updated. Kim York received a quote from Midstate. Hetland moves to go ahead with the quote as long as it is in the budget. Schroeder seconded the motion. Mayor declares all ayes, motion is carried.

Mayor Kim Ehlers spoke with Ed Peters in regards to the elevator to block it up for more storage and the front door leaking. Ed Peters is looking into quotes on both projects. Ehlers also asked if we can insulate the walls between the finance office and the library. Found that it will probably not be able to do so.

Ehlers wanted to review the junk care ordinance. Schroeder explained why there is a grey area per the lawyer. Nothing further was discussed.

Schroeder Moves to go into executive session SDCL 1-25-2 for personal and legal. Hetland seconded the motion. Mayor declares all ayes, motion is carried.

Ehlers declares executive session over at 7:57 pm.

Hetland motions to hire Jewel McGeough, Kyza Johnson, Katilyn Mohnen, and Celina Trisco for lifeguards at \$15.00/hr and Landon Moeller at \$15.50/hr. Schroeder seconded the motion. Mayor declares all ayes, motion is carried.

Hetland moves to hire Evan Snedeker to help Josh at \$14.50/hr. Schroeder seconded the motion. Mayor declares all ayes, motion is carried.

Guericke moves to hire Sara Wells at Daycare at \$14.25/hr. Schroeder seconded the motion. Mayor declares all ayes, motion is carried.

Schroeder moves to adjourn the meeting at 8:06pm. Hetland seconded the motion. Mayor declares all ayes, motion is carried. Next City Council regular meeting will be June 9th at 7pm.
