- -Announcement and introduction of Chuck Schulze who is the Senior Property Manager & Director of Business Development.
- -Creation of Community Guidebook that can be found on the new Edgewood at Everlands Website that is meant to help simply the HOA declarations
- -Creation of ACC Operations Guide, incorporating drawings, paint color charts and model elevations/plans.

- -We have been working closely with a towing company that will help us control some of the overnight parking issues that plague us. Lee's Towing Company

- -Tim has worked with our attorney to complete the Edgewood at Everlands Appeals & Hearing Panel. This will be chaired by Robert Shoff. This committee will work with homeowners who have received violations and

- -Tim discussed the Blue Stream Media contract and informed homeowners that it was signed for 10 years and of the hefty fine that would be charged to us if we broke the contract early.

- -Repairs completed are bathrooms locks replaced, several fence repairs due to people climbing the fence to gain access to the pool, installation of wildlife signs at both ends of the pond and pool filter replacement and equipment repairs

Treasurer's Report

- -Explanation that we are still waiting on banking information from the previous management company.
- -Discussed late dues and that they were never addressed by the previous management company and that we are now in the process of working with the attorneys to place liens on these homes.
- -Requested homeowners to please make sure that they have completed the updated Keystone packet so that they do not start getting late fees on their HOA dues.
- -We have paused the installation of flowers at the front of the entrance until the gates and cameras have been installed.
- -Talked about possibly lowering the number of times that the cleaning lady comes to clean the cabana to save some money.

- -Discussed the pin pad access that is at the pool and that the IP address has been misplaced by the previous management. Working on a better solution for pool access
- -Discussed the issue that we are having with fencing/plants placed over drainage areas and swells and the need to involve the lawyers to address flooding concerns
