
### Survey summary / 問卷調查總結

- The Medical Licentiate Society of Hong Kong surveyed non-locally trained doctors to collect their views and experiences on the impact of the new coronavirus outbreak on their medical practice in Hong Kong and on Hong Kong's healthcare.
- 香港執照醫生醫學會向非本地訓練醫生進行了問卷調查,以探討新型冠狀病毒對他們自身臨床工作和香港整體醫療體系影響的經驗及看法。
- The non-locally trained doctors are the LMCHK doctors, a community of overseas, overland, and foreign doctors in Hong Kong that hold the medical license qualification known as Licentiate of the Medical Council of Hong Kong (or LMCHK) and of those actively preparing to achieve said qualification.
- 「非本地訓練醫生」團體包含「執照醫生」(在香港執業的海外,內地及外籍醫生的群體,擁有香港醫務委員會執照醫生資格)及目前在準備考取以上資格的醫生。
- The survey was conducted between 1 Feb 2020 (19:00 HKT) and 4 Feb 2020 (22:00 HKT) and resulted in 230 respondents.





#### Q: The coronavirus outbreak has affected my work in clinical practice?



#### Q: If 2019-nCoV has affected your work, in what ways has it? Check all that apply:




#### Q: Has your employer arranged different work options for you? Check all that apply:





問題:你對當局在新型冠狀病毒疫情控制工作的評價?



The Licentiate Society was founded on 15 June 2017 and incorporated on 26 November 2019 to support the LMCHK (Licentiate of the Medical Council of Kong) community and to engage with the public and other medical professionals both in and out of Hong Kong. The group also supports candidates of the Hong Kong Medical Licensing Examination. The Licentiate Society is the only incorporated entity dedicated to the LMCHK physician community.
