We bring you this report with our sincere gratitude for supporting Warm Water Wellness Inc in our efforts to reopen the Mack E. Mickelson Arthritis and Rehabilitation Center pool and bring access to warm water therapy back to San Mateo County. It is well-known that the Mickelson pool at the Mills Health Center was a vital community resource that helped disabled individuals and seniors stay active and independent.

We are pleased to report that several months ago, **Sutter Health announced that they will reopen the pool in early summer 2024!** On September 28, 2023, Sutter announced that **repairs/reconstruction of the Mickelson pool will begin in November 2023**.

Since forming Warm Water Wellness Inc in 2021, we have worked tirelessly to publicize our opposition to the pool's closure and advocate for warm water therapy... at council meetings, commission meetings, and Zoom meetings, as well as through individual conversations and officeholder meet-and-greet events. We've made significant progress in explaining the impact of the pool's closure and educating our elected officials and others about the need for warm water therapy pools. Through our work, Warm Water Wellness is now recognized as the local expert on therapy pools.

Although we welcome the above news from Sutter, our work is not done. We need to make sure that Sutter follows through on their commitment to reopen the pool. We also need to ensure that the reopened facility will offer sufficient hours and access. We will not rest until everyone who needs the benefits of a therapy pool has access to one.

About Us

Warm Water Wellness Inc was formed as a non-profit in October 2021 in response to Sutter Health's closure of the Mickelson therapy pool in San Mateo.

Our mission is to strongly promote warm water therapy resources in San Mateo County for seniors, disabled adults, children with special needs, and individuals with other medical conditions.

Board members include former therapy pool users and supporters.

The Mickelson Therapy Pool

The Mack E. Mickelson Arthritis and Rehabilitation Center Therapy Pool was built 27 years ago at Mills Hospital in San Mateo (now known as Mills Health Center) with \$4M in community donations. It is the only fully accessible warm water therapy pool on the Peninsula. Those who used the pool came from cities and towns all over the county, as well as surrounding communities.

Sutter Health assumed management of the pool in 2007 and users witnessed decreased maintenance and staffing. Pool hours were reduced and some classes canceled in January 2020. The pool was closed by Sutter Health in March 2020, allegedly due to the COVID-19 pandemic.

Why is this pool so important?

Warm water therapy is widely accepted and recognized as an effective yet gentle form of exercise that is particularly beneficial for chronic and disabling conditions.¹

San Mateo County residents are "graying." By 2030 (just 6 years from now), people over the age of 65 will represent 30% of San Mateo County's population, and the number of disabled persons over 65 will increase by 148%.² Currently, 1 in 4 people in the U.S. is disabled, and that number will grow with the increasing senior population.

The numbers (and our own experience) tell us that warm water therapy pools are absolutely vital, necessary, and deserved by both the senior and disabled communities. Through regular use, pool users remain independent, exercise safely and regularly, and need less assistance as they age.

66 I have muscular dystrophy and a warm-water pool is the only place I can exercise in a way that strengthens and supports my degenerating muscles. I used to drive from San Francisco because this pool is a rare gem that is accessible, beautiful and essential to maintaining my health.

Our Impact

EDUCATION

Recognizing the need for education on the benefits and the value of warm water therapy pools, we researched and published detailed information on these pools, their requirements, and why we are fighting to return them to the Peninsula. Through our presentations, correspondence, and personal conversations, *every city councilmember* in the County became fully aware of the impact of the Mickelson pool's closure and the harm being wrought on the most vulnerable in our community.

FOCUS

Through articles, op-eds, and letters, we increased awareness of the benefits of warm water therapy pools. This drew the attention of the public, local and state legislators and other organizations to the plight of former pool users.

ALLIANCES

We established strong collaborative relationships with the San Mateo County Board of Supervisors, the Peninsula Health Care District, the Sequoia Healthcare District, the San Mateo County Central Labor Council, every city council in the county, and many others concerned with the health and well-being of the community. As a result of this outreach, each of these entities sent a resolution, proclamation, or letter to Sutter Health corporate calling for the reopening of the Mickelson pool.

Highlights

We researched local community pools for possible therapy use; all were found lacking in essential therapy pool amenities.

We wrote to the many individuals, companies and foundations who donated to the pool's construction, advising them of the impact of the closure.

We contacted Sutter Health management many times, both locally and at the corporate level, inviting them to discuss the situation with pool users and other interested stakeholders.

We published a reference paper entitled "The Need for Warm Water Therapeutic Resources on the Peninsula."

We created a website as an informational resource on the benefits of warm water therapy and ramifications of Mickelson Center's closure.

We attended numerous meetings (virtually and in person) requesting that the Peninsula Health Care District, the Sequoia Healthcare District, and the County of San Mateo Supervisors urge Sutter Health to reopen the Mickelson pool.

We spoke at regular meetings of all 20 City/Town Councils in San Mateo County, as well as to many individual city councilmembers, encouraging them to pass resolutions, proclamations or write to Sutter Health about reopening the pool.

Highlights

We produced op-eds, letters to the editor, and press releases for *the San Mateo Daily Journal, SFGATE, Mercury News, Everything South City, Climate, Opera News, Patch, Indybay, NBC, KRON4, KPIX 5, BOLLYINSIDE, The Almanac, Redwood City Pulse,* and *KCBS.*

Sutter Health is committed to reopening the Mickelson Center warm water therapy pool which was closed at the start of the COVID-19 pandemic.

Our teams have assessed the work needed to reopen the pool and following that analysis, we've committed to investing in the project and are moving forward. We are in the process of applying for necessary permits before work can begin, and anticipate that the pool will be ready for our patients in early summer 2024, pending no unforeseen delays.
