We were asked to work in small groups (4 groups of 3) to come up with five objectives of Goal #2 using the above formula.

The following objectives were suggested for Goal #2.

- a. Small group conflict conference
- b. Address concerns of two-point charge
- c. Need to communicate **facts** to people in different ways – **AGAIN**
- d. Intentional Conversations
- e. Create safe environment to air future problems (train our facilitators)
- f. Promote a culture of forgiveness
- g. Increase inclusiveness (meet and greet)
- h. Utilize the Coffee Café after church service

After brainstorming and discussion the group decided to set a date for Tony to come back and meet with our congregation for “Healing Conversations” on Sunday, September 9, 2019 with no more than 6 people per session in the time slots listed.
