| Planning the 2 nd Edition | Contributors | |
| | Names of authors and reviewers for new chapters were suggested. Pat will update the Contacts to list these new contributors Pat proposed that we accept 2-3 authors for two chapters, inorganics and cannabis, have authors propose outlines by the end of March and begin writing. A chapter on botanicals instead of only cannabis was suggested Julie suggested that the scope of the content needs to be defined. There are needs for matrix reference materials. There are different markets for cannabis and hemp. | |

- Pat described how the first edition was written to be relevant for all reference materials and the additional chapters should refer to previous material and not rewrite it. Cannabis has some unique issues including shipping and regulations.
- Joe K asked: How well does the current guide handle cannabis and botanicals? What enhancements do we need?
- Julie mentioned that there is a different audience for cannabis and it might be useful to have a chapter that covers this issue while referring to other chapters for relevant information.
- Pat reiterated that the Ref Ma should be relevant for all materials. There are many special topics that could be discussed such as pyrolizing alcoloids, Cannabis has special issues such as identity, certification, legality and transportation.
- Julie mentioned that there are many different matrices of cannabis that need to be addressed: flower, plant, concentrated, extracts, edibles, topical...
- Melissa said she struggles to combine both botanicals and cannabis together.
 Authenticity is a big issue with a variety of different botanicals. Cannabis is a specific material
- Pat mentioned the specific issues with cannabis include legality, shipping, availability, adulteration, counterfeiting...
- Jo Marie suggested that it seems we have three chapters: inorganics, authenticity and cannabis
- Joe mentioned that authenticity is not as straight forward an issue. It includes targeted, non-targeted, gmo...
- Pat liked the approach and wondered if we should write the inorganics and authenticity and then write the cannabis chapter later,
- Jo Marie suggested that if we consult with other experts and develop a good outline for the content, we can then write all three chapters concurrently.
- Jo Marie wondered if there is international participation that we need.
- It was mentioned that we need Canadian and S. American input in cannabis issues.
- Pat said that we could review the current guide, put together a list of gaps in the current content and then put it out to the whole working group for comment. From the list of gaps, we can outline the content for future chapters.
- Melissa suggested that we reach out to John Spylka, Joe Boisen and Danille from the AOAC CAST subgroups.
- Pat asked if Melissa and Joe K could work together to identify the people who
 might be solicited as contributors, especially from other countries.

Regulatory status of Best Practices.

- Julie mentioned that AOAC Cast group might have some of their documents adopted into law.
- Joe K described how the RefMaTrA is a "Best Practices" and not a "Guide" to avoid any misunderstanding that it the recommendations were requirements.
- Jo Marie mentioned that NACRW is not a consensus building organization and could not make legally binding recommendations but regulatory agencies could adopt the Best Practices or some rewrite of them.
- Joe K mentioned that the RefMaTrA is intended to be a benefit and resource to users of reference materials, but it is not a consensus organization document.
- Jo Marie mentioned that it is important to have regulatory agency input. The
