- industry is changing at lot.
- Matt N (?) indicated that the industry really needs materials sooner is better
- Pat explained that we are not in a position to provide regulatory guidance. This group can only make general recommendations and much of the 1st Edition already applies to cannabis
- Melissa P added that the 1st edition will also apply to cannabis and also for botanicals. The missing piece is authenticity. Melissa, Joe K, Joe Boison and John Spylka will be meeting to discuss AOAC plans for work on this topic and will bring information back to the Working Group.
- Pearse McC agreed that the 1st edition is generic and good for all materials and suggested to be cautious about providing recommendations for specific matrices. He also agreed that inorganics and authenticity were gaps that might be added in a 2nd Edition.
- Pat A mentioned the use of substitute matrices in cannabis and other methods and asked if topic might be included under authenticity.
- Matt N added that the general scope of the current guide is great. He
 added that the cannabis industry is not at a point where much of the
 information in the RefMaTrA is being addressed. For example, he
 explained that hemp is being substituted for cannabis and is a much
 different matrix
- Melissa described how different validations for authenticity include inclusivity and exclusivity statements. Maybe generic statements might be made about substitution.
- Jo suggested that perhaps this NACRW Working Group could compose a cannabis white paper which discusses the reference material issues specific to cannabis instead of adding a separate chapter to RefMaTrA.
- Melissa asked is there anything else that should be considered for botanicals and other matrices
- Laura added that we don't have materials for cannabis and we don't have methods to prepare these types of RMs
- Pat called for those interested in writing a Cannabis RMs white paper.
 Pearse will recommend contacts in Health Canada. Laura and Matt Lasater will help.
- Pat asked if we should pursue "Authenticity" as a chapter
- Melissa indicated that she did think it was needed and described how the methods used are very different from contaminants analyses.
 Matrices are very different from honey to olive oil to turmeric to cannabis. We need to describe how we can have more confidence in our methods by using RMs
- Pat indicated that we will pursue a chapter on authenticity and asked for volunteers to work on this topic
- Jo described the call for sponsors to support the Working groups.
 Sponsors will be recognized at the beginning of the document as well as at the end with a list of RM producers. They will also receive a list of those who are downloading the RefMaTrA from the website. Jo asked that producers and providers help get the word out by posting a link to the RefMaTrA on their websites and mentioning it in their presentations.
- Pat and Joe K are putting together a list of producers of RMs
- Markus O will provide a list of international providers
- Pat will compile a list for review by the other providers on the Working Group
