#### Statutory Obligation

Pursuant to T.C.A § 16-2-505(d), each county must establish a court security committee. In addition to the sheriff, the Committee is to be composed of the county mayor, the district attorney general, the presiding judge of the judicial district, and the court clerk from the county designated by the presiding judge. The Committee is charged with examining the space and facilities to determine the security needs of the courtrooms in the county in order to provide safe and secure facilities.

Upon completing the examination of security needs, the administrative office of the courts distributes to the court security committee a copy of the minimum-security standards as adopted by the Tennessee Judicial Conference. The Committee must review and consider these standards in determining court security needs. No later than May 15 of each year, the court security committee must report its findings to the county legislative body and the administrative office of the courts. The county legislative body is required to review and consider the recommendations of the court security committee in preparing the budget. Any recommendation by the court security committee requiring county expenditures is subject to the approval of the county legislative body. No later than December 1 of each year, the county legislative body must report to the administrative office of the courts any action taken to meet the security needs. No later than January 15 of each year, the administrative office of the courts is required to report to the General Assembly on the compliance of each county government with the security needs established by the court security committee.

# Tennessee Courtroom Security Standard

The approved court security criteria include the following:

- Silent bench and court clerk's public transaction counter panic button connected directly
  to the sheriff's or police departments.
- 2. A bullet-proof bench and court clerk work area in courtrooms.
- Ensure the availability of an armed, uniformed guard (court officer) in each courtroom during court sessions.
- 4. Court security training for court officers. Court security briefings are held on an annual basis for judicial staff and courthouse personnel.
- 5. Hand-held detectors (minimum of 2) and/or magnetometers in each county to assure safety in each courthouse or courtroom.
- 6. Each court building shall have signage posted at each court access entrance stating that all persons are subject to search by security personnel. Prohibited items are subject to seizure and forfeiture. Prohibited items include, but are not limited to, the following: firearms, other forms of weaponry, and any item(s) that can be transformed into a weapon.
- 7. A hand-held inspection security mirror is to be used to view under courtroom seating and other areas for safety in the courthouse and/or courtroom(s).

The new standards were approved by a general sessions court committee and a committee representing state circuit, criminal, and appellate judges. Members include Tennessee Judges Conference (T.J.C.) Court Security Committee: John McLellan – Chair, Tammy Harrington, Amy Hollars, Jim Kyle, Eddie Lauderback, Don Parish, Russ Parkes, John Wootten, Jr.; and Tennessee General Sessions Judges Conference (TGSJC) Court Security Committee: Paul Conley, Danny Goodman, Michael Davis, Katerina Moore, and Floyd Rhea.

# Court Security Committee Meeting Minutes

On Thursday, February 28, 2024, The Lauderdale County Court Security Committee members met at the Lauderdale County Sheriff's Office. Sheriff Brian Kelley, Lauderdale County Mayor Maurice Gaines, Assistant District Attorney Amy Wyrick, Judge Kasey Culbreath (presiding judge), and Shirley Robinson (acting for Lauderdale County Circuit Court Clerk) were in attendance.

Minutes from the prior meeting were accepted and attached for reference.

Sheriff Kelley updated the Committee on improvements since the last meeting and the implementation of grant funding. These include:

- The overflow court has been constructed and utilized by Chancery Court.
  - o 3 courts have been convened at one time recently.
- Approximately \$14,000.00 worth of new Kevlar has been ordered.
  - o Court Clerk Benches
  - o New overflow court.
  - o Court Clerks public area.
- Currently in the process of using the court security grant to update:
  - Storage lockers
  - o Entry metal detector.
  - o Inmate security mechanisms for court.
  - o Update cameras for better coverage.
  - o Update alarm buttons where necessary.

Mayor Gaines provided additional information on repairing the panic button at the Court House and presented information that it was functioning as needed.

The discussion moved to the functionality and security of multiple courts at the Lauderdale County Justice Complex and Court House. Judge Culbreath expressed appreciation for the ease of transition of the move of Chancery Court from the courthouse to the justice complex.

Mayor Gaines provided information on the current attempt to move the juvenile court to the justice complex and said he is monitoring the situation to accommodate every court. Mayor Gaines spoke on the overall goal of moving all court business from multiple locations to one roof at the Lauderdale County Justice Complex to serve everyone better. Mayor Gaines advised that he was working with Attorney Micael Banks to accomplish this goal.

Sheriff Kelley presented the Committee with a time study of the General Sessions Court and the Juvenile Court, which is attached as a reference.

After discussion, Judge Culbreath made a motion to move forward with consolidating the courts to the Justic Complex, with General Wyrick seconding the motion. The Committee voted unanimously that it was in the best interest of security for all courts and that this motion be forwarded to the County Commission.

The meeting adjourned with no additional business.

# Courtroom Security Committee Meeting

On Monday, August 1, 2D23, as directed by Tennessee Code Annotated 16-2-505(d), a Courtroom Security Committee was convened with the Lauderdale County Sheriff, Lauderdale County Mayor, District Attorney General of the 25<sup>th</sup> Judicial District, Lauderdale County Court Clerk, and the presiding Judge of the 25<sup>th</sup> Judicial District. This meeting intended to address security concerns presented by Judge Rachel Jackson, specifically the security of the Lauderdale County Court House and courts contained within.

#### Overview

Tennessee is home to 98 juvenile courts, and of these, 17 are designated "Private Act" juvenile courts. Subsequently, 81 courts are general session courts with juvenile jurisdiction. Lauderdale County continues to operate under such a "Private Act," creating unique issues.

Furthermore, The Lauderdale County Courthouse is in the heart of Ripley, TN, and is listed on the National Register of Historic Places. The courthouse holds multiple offices of county elected officials operating individually. Because of this, the Sheriff must balance the security of the courts within the facility and the rights of the citizens and the elected officials, as the courthouse remains a public building.

#### Discussion

Currently, above minimum standards are met when it comes to the State of Tennessee recommendations, including the addition of a bulletproof window behind the Judge's bench as well as the locking of three of the four main entrances into the facility, which proves to be highly restrictive to citizens seeking to conduct business.

Though additional modifications have been made, additional concerns loom from Judge Jackson. Also, due to the historic nature of the building and it being a public facility, the ability to physically secure the entire building would prove financially straining and highly restrictive to the public.

Additional issues remain in that the courtroom within the courthouse is outdated and needs timely repairs. This creates unique issues because, as it is a historic site, the historical society must approve before any modification can be made. It is anticipated that meeting the requests and conducting the repairs needed to the facility will take multiple years and extensive taxpayer dollars.

Through the meeting, all concerns were addressed, and a unanimous decision was made that it was in the best interest of the courts and the county to move all courts in Lauderdale County to a central location at the justice complex. The Justice Complex is by far the most secure facility in the county, which provides one point of egress, which is manned during all business hours as well as fully staffed with full and part-time security staff.

#### Concerns Addressed

Unique questions were raised, as well as solutions as follows:

#### Availability of Courtrooms:

Currently, the circuit court is only in session a few days of the month, thus creating an empty courtroom where proper scheduling will allow for multiple courts within one courtroom.

#### Technology and Court Clerks:

A concern was raised that there is a need for the Court Clerks to have adequate technology as well as a place to conduct business. As the courtrooms are set up with the needed technology, additional accommodations will be made within the justice complex to provide an adequate workspace as well as the technological needs to conduct all business needs.

#### Movement of Files:

A concern was raised about how court files will be transferred from their point of storage to court. Currently, the district attorney's office transports its own files to and from its office on the square. It is suggested that other court clerks will do the same. To further accomplish this, it is suggested that the court security officers can assist in the transfer as needed.

### Juvenile and Adult Interaction:

Comments have been made in reference to total sight and sound when it comes to juvenile and adult interactions.

In a review of Tennessee Code Title 37-1-116 and 34 U.S.C.A. §11133(a)(12)(A), the legal requirement for sight and sound separation between juveniles and adult inmates states that "juveniles alleged to be or found to be delinquent will not be detained or confined in any institution in which they have sight or sound contact with adult inmates."

In short, Lauderdale County does not house juveniles for the purpose of detention and utilizes secondary facilities for this purpose. Courts throughout Tennessee, such as Tipton County, successfully navigate various courts in one setting. To be overly conscious of the concerns, it is suggested that the Sheriff can restrict the movement of adult inmates in the facility while juvenile offenders are present; this includes but

is not limited to the movement of trustees, the action of adult offenders in other courts, as well as segregation of facility holding cells.

#### Payment of Fines and Costs:


Concerns were raised over fines and court costs being paid traditionally at the respective Court Clerk's office. It was determined that costs could be maintained in one of two ways. Payors can travel to the respective court clerks' offices and return to the courts with receipts. Alternatively, payments may be taken by the respective clerk at the justice complex and transported the funds back to the respective court clerk's office. Members of the Sheriff's Office agree to assist in transporting personnel with funds back to their office for security measures.



# 2021 Tennessee Code Title 5 - Counties Chapter 7 - County Buildings and Property § 5-7-111. Replacement of Courthouse or Jail — Authorization

Universal Citation: TN Code § 5-7-111 (2021)

Whenever, in the opinion of a majority of the members of the county legislative body, two thirds (2/3) of them being present, the site of a jail or public prison, or courthouse, is unhealthy, insecure or inconvenient in its location to the county or to the town, or inhabitants of the town, in which it is situated, or the interest and convenience of the town would be promoted by the removal of any of the same, the members may order a sale of the site, and of the whole or part of the materials used in its construction; and they may also order that a more eligible, convenient, healthy or secure site be purchased, and cause to be erected thereon a new jail or courthouse, better suited to the convenience of the town, and to secure the safe custody, health and comfort of inmates.

Judge Rachel Jackson, Juvenile/Probate, read her prepared statement to the Lauderdale County

#### Commission, as follows:

#### Commissioners:

I regret that I have to appear before you tonight on issues related to the court. There was no request on my part that prompted this issue; I am merely defending an imposition on the judicial branch. On two prior occasions, I have allowed an unlawful imposition, to the detriment of the workings of the Court, so on this occasion I will not. On two prior occasions on this issue alone, one of those being on the County Attorney's clear indication against the Sheriff's request, the Commission has decided against that request, only to hire a new attorney to give you a different opinion.

I have read all the law relative to this issue, including CTAS opinions. Some of you will not be surprised to know that CTAS, in giving those opinions, appears to incorrectly read the cases they cite, if they read them at all. I called that to Mr. Banks' attention and encouraged him to read the cases for himself to confirm that.

On the topic that is before you, the law imposes a duty on the Sheriff to provide security wherever Court is in session. It gives him no authority to direct the Court on where court is held.

The law *may* allow the Commission to discontinue the use of this Courtroom, if that is reasonable; I do not believe it is at present. One might argue that the name "Courthouse" on the outside of this building, the room's existence as an accommodating courtroom for roughly 100 years, and its structurally sound condition as a meeting room for yourself is enough evidence of 'reasonableness' for its existing use. If it was not, I would have already abandoned it myself.

But if I were to show up here tomorrow and you have removed the bench or locked the doors or some such action, what the law doesn't allow you, the Sheriff, the Courtroom Security Committee, or anyone else to do is to tell me where I go next to hold court. Judge Lovelace and I have already told you and your committee that neither a) the sharing of the existing General Sessions Courtroom or b) the use of any other existing space at the justice center is reasonable and will allow us to meet the requirements of state and federal law relating to the timing of hearings or space accommodation of litigants and/or the public. We are trying to lend our knowledge, experience, and expertise in a way that keeps this county from being the subject of another federal court lawsuit. But this is just to say that we have already determined that I cannot, presently, reasonably hold court at the justice center.

So I will choose a place that is reasonable for court sessions. That law provides that may be any other structure within the county seat or, if no suitable place is available, outside the county seat. The law also provides that a) it is the Sheriff's duty to show up wherever that is, and to provide security, and b) the Clerk must show up wherever that is and perform her duties. Both are subject to the contempt powers of the Court for failing to do so, and I think the implications of that are clear.

You will presumably do, not what is popular with the Sheriff, but what you believe is lawful. If I file suit on any of these issues to defend the judiciary's position, the costs of that lawsuit will be in furtherance of my role as a County judge, so the County will bear those costs. Again, that will be unfortunate, but clear. The law allows me to issue a court order that those costs be paid, and to have a higher court enforce it if they are not paid.

I ask you all only to remember that none of this was prompted by me, and that it is all completely avoidable.
