For the purposes of this participation, waiver and release agreement, "Event" means the training and recreation classes run by Falcon Fencing Club ("FFC-Sport") you are registering for as part of this on-line or in person paper registration process and all transportation to, from and between Event locations, and all other activities related to the Event. By clicking and accepting the box for this participation, waiver and release agreement and by completing the on-line registration process, you agree as follows:

1. ASSUMPTION OF RISK.
