If this happens, we will do our best to treat our travelers as fairly as possible. Airlines may impose cancellation and change penalties. Some of our hotels may impose cancellation and change penalties, too. These fees may not be recoverable by Quotelos Travel, and as such, would not be refunded to you. Quotelos Travel cannot guarantee a full refund in the event of a cancellation, but we do pledge that any recoverable charges and fees would be refunded to you, regardless of our documented cancellation policy. Please consider this before you complete your registration.

- **CANCELLATION POLICY:**

Please consider trip insurance! Quotelus will refund all payment that we can recoup from our vendors, less a \$200 fee. The refund amount varies from vendor to vendor. Vendors generally include transfers/transportation, meals, hotel accommodations, and entrance fees.

- **AIRLINE TICKET REFUND:**

- **HOTEL ACCOMMODATIONS:**

The hotels included in the tour itinerary offer comfort and value for category selected. We use hotels similar Holiday Inn in the United States.

- **TOUR ITINERARY:**

We reserve the right to modify and/or change the sequence of the itinerary due to unforeseen circumstances, safety security and comfort of the passenger.

- **TOUR GRATUITIES:**

Our packages do not include tipping for bus driver. Suggested tipping: \$3.00 per person per touring day.

- **LUGGAGE AND PERSONAL PROPERTY:**

It is the passenger's responsibility to check the specific airline policy of liability for loss, damage or delay of checked baggage as well as the maximum allowance of weight per bag and number of checked or carry-on bags permitted at no cost and additional charges imposed by the airlines including excess baggage. Luggage and personal property loss or damages must be reported to the airline or ground transportation company at the destination. Quotelos Travel does not accept liability for loss or damage of luggage or personal property.

- **PHYSICAL ACTIVITY & HEALTH CONDITION:**

Most tours require walking that may include uneven and un-pathed surfaces, cobblestone streets, steps and inclines. Some days may include walking distances of 2+ miles. It is the traveler's responsibility to determine if they have the physical ability to participate and keep up with the normal pace of a group tour. The traveler must inform Quotelos Travel of any medical/health circumstances that may restrict their physical ability in any way whether joining a guaranteed departure tour, day tour or securing a private tour. The purchase of optional travel insurance is highly recommended.

- **PASSPORTS AND DOCUMENTS:**
