Discounts may not be combined. The Shipping & Chute Fee and all other applicable charges are separate from the Stallion Service Fee and are not reduced by any discount.

Veterinary, reproductive, boarding and other expenses incurred by the mare are not included and are the responsibility of the Mare Owner.

## TERMS & CONDITIONS

### 1. Contract & Mare Eligibility

This agreement provides one breeding to Tis The Cat for the mare identified above and is intended to result in one live foal.

The Mare Owner represents that they are the current registered owner of the mare and agrees to provide a copy of the mare's registration papers upon request. The mare must be healthy, reproductively sound and suitable for breeding.

This agreement is **non-transferable and not for resale** except as expressly permitted in writing by the Stallion Agent.

### 2. Discounted Services

Any discount, promotional rate or special consideration applies only to the mare identified in this Agreement and the 2027 breeding season.

Discounts have no cash value, may not be transferred and may not be combined unless specifically authorized in writing by the Stallion Agent.

Eligibility for the Multiple Mare, Proven Mare and Early Booking discounts is subject to verification by the Stallion Agent.

If a Mare Owner contracts multiple mares, **each mare must have a separate Stallion Service Agreement.**

Discounted Stallion Service Fees do not reduce or waive the \$700 Shipping & Chute Fee or any veterinary, courier, reproductive, boarding or other applicable charges.

### 3. Payment

The **\$500 non-refundable Booking Fee** is due when this Agreement is submitted and will be applied toward the Agreed Stallion Service Fee.

The remaining balance of the Agreed Stallion Service Fee must be **paid in full prior to the first semen shipment or on-site breeding.**

**A \$700 Shipping & Chute Fee is due prior to each semen shipment.**

Any additional courier or other applicable charges must also be paid before semen will be released or shipped.

**No semen will be shipped or released until all amounts then due have been paid in full.**

Any balance more than 30 days past due may accrue a finance charge of 1.5% per month or the maximum amount permitted by Oklahoma law, whichever is less.

No breeder's certificate or other breeding documentation will be released until all amounts due under this Agreement have been paid in full.

#### **4. Cooled Semen**

Tis The Cat is generally collected **Monday, Wednesday and Friday**, subject to availability. Collection days may change due to showing, travel, veterinary considerations or other circumstances.

The Mare Owner or attending veterinarian must:

- Give at least **24 hours' advance notice** of a requested shipment; and
- Confirm the shipment by **8:00 a.m. Central Time** on the collection day.

Shipment requests and cancellations must be made by phone or text to the Stallion Agent. Requests by email are not accepted.

Late cancellations may be subject to collection, processing, courier or other costs already incurred.

A maximum of **two shipments per breeding cycle** will be provided.

#### **5. Shipping & Containers**

The Mare Owner is responsible for the \$700 Shipping & Chute Fee for each shipment and any additional applicable courier or delivery charges.

Shipping containers must be returned to Weber Performance Horses LLC within **48 hours of receipt**.

Containers not timely returned may be charged **\$25 per day** until returned.

The Mare Owner assumes responsibility for delays, loss or damage occurring in transit. The Stallion Owner and Stallion Agent will use reasonable care in collecting, processing and preparing semen for shipment but cannot guarantee carrier performance or semen viability after shipment and handling outside their control.

#### **6. Semen Use**

All semen provided under this Agreement may be used **only for the mare identified in this Agreement** unless a mare substitution has been approved in writing by the Stallion Agent.

Semen may not be sold, transferred, gifted, used to breed an additional mare or retained for unauthorized future use without prior written authorization.

Any unused semen remains subject to the terms of this Agreement.

#### **7. Stallion Availability**

Tis The Cat may be competing, traveling or otherwise unavailable during portions of the breeding season. Reasonable efforts will be made to accommodate each mare; however, semen availability is not guaranteed on every requested breeding date.

If cooled semen is unavailable, frozen semen may be provided when available.

Neither the Stallion Owner nor Stallion Agent is responsible for missed breeding cycles resulting from stallion availability, shipping or carrier delays, weather, circumstances beyond their reasonable control, or failure of the Mare Owner or attending veterinarian to timely request semen.

## 8. Breeding Management

Breeding and insemination should be managed by a licensed veterinarian or qualified reproductive professional.

The Mare Owner and attending veterinarian are responsible for reproductive management of the mare, including timing of insemination and appropriate pregnancy examinations.

No representation or guarantee is made regarding conception from any individual shipment or breeding cycle.

## 9. Pregnancy Reporting

To maintain eligibility for the Live Foal Guarantee, the Mare Owner agrees to have the mare examined for pregnancy by a licensed veterinarian.

Pregnancy examinations are recommended at approximately:

- 15 days post-ovulation;
- 30 days; and
- 60 days.

The Mare Owner agrees to timely notify Weber Performance Horses LLC of the mare's pregnancy status and provide veterinary documentation upon request.

## 10. Live Foal Guarantee

This Agreement includes a **Live Foal Guarantee**, provided the Mare Owner complies with the terms of this Agreement.

A "Live Foal" means a foal that is born alive and is able to stand and nurse.

If the mare aborts, miscarries or delivers a stillborn foal, the Mare Owner must notify Weber Performance Horses LLC and provide a written statement from a licensed veterinarian within **seven (7) days** of the occurrence.

If these requirements are met, the Mare Owner will receive one rebreed privilege for the **immediately following breeding season** upon payment of a **\$250 rebreed fee**, plus all applicable shipping, chute, veterinary and other charges.

The rebreed privilege expires at the end of the immediately following breeding season and has no cash value. Failure to use the rebreed during that season terminates the rebreed privilege and all obligations under the Live Foal Guarantee unless otherwise agreed in writing.

The rebreed privilege applies only to the Mare Owner and mare identified in this Agreement unless a substitute mare is approved in writing.

**No Stallion Service Fee will be refunded under the Live Foal Guarantee.**

## 11. Mare Death, Infertility or Substitution

If the contracted mare dies or becomes reproductively unfit to breed, the Mare Owner may request substitution of another mare during the current breeding season or immediately following breeding season.

Substitution requires:

1. Written documentation from a licensed veterinarian confirming the original mare's condition; and
2. Approval of the substitute mare by the Stallion Agent.

An administrative fee of **\$25** may apply to an approved mare substitution.

Mare substitutions are not permitted for a mare already being bred under a rebreed privilege unless specifically approved in writing by the Stallion Agent.

## **12. Stallion Death or Infertility**

If Tis The Cat dies, becomes permanently infertile or is otherwise unable to provide breeding service before semen has been provided under this Agreement, this Agreement may be terminated.

In that event, amounts paid toward the Stallion Service Fee will be refunded, less the non-refundable Booking Fee and any collection, shipping, veterinary or other charges already incurred.

If the mare is already in foal or the Mare Owner has received and used semen under this Agreement or an applicable rebreed privilege, no refund will be due except as otherwise agreed in writing.

## **13. No Guarantee of Foal Characteristics**

Except for the Live Foal Guarantee expressly stated in this Agreement, no guarantee or warranty is made concerning conception, pregnancy, foaling outcome, sex, color, size, conformation, disposition, performance ability, merchantability, fitness for a particular purpose, genetic expression or future value of any resulting foal.

## **14. Limitation Regarding Semen & Shipping**

The Stallion Owner and Stallion Agent will use reasonable care in the collection, handling and preparation of semen.

Neither the Stallion Owner nor Stallion Agent is responsible for loss of semen viability, contamination, delayed delivery, lost shipments, improper storage or improper handling after the semen leaves the collection facility's control, except to the extent otherwise required by applicable law.

## **15. Role of Stallion Agent**

Weber Performance Horses LLC acts solely as the **authorized Stallion Agent for Tis The Cat** in administering breeding contracts, payments, semen requests and related breeding-season services. Nothing in this Agreement shall be construed as representing Weber Performance Horses LLC as the owner of Tis The Cat.

## **16. Entire Agreement**

This Agreement contains the entire agreement between the parties concerning this breeding and supersedes prior oral or written representations concerning the breeding.

Any modification, exception or waiver must be agreed to in writing by the Stallion Agent.

If any provision of this Agreement is found unenforceable, the remaining provisions will remain in effect to the fullest extent permitted by law.

This Agreement will be governed by the laws of the State of Oklahoma.

## **17. Oklahoma Livestock Activities Notice**

The parties acknowledge that activities involving horses carry inherent risks. Nothing in this Agreement is intended to waive or limit any right or liability beyond what is permitted under applicable Oklahoma law, including the Oklahoma Livestock Activities Liability Limitation Act.
