ELIGIBILITY

Higher Secondary [10+2] or its Equivalent Examination.

Minimum Percentage in the Qualifying Examination:

45% for **General** Category applicants

42 % for **OBC**

40 % for **SC** and **ST**

Candidates must be appearing / passed out in the current year or in the last preceding two years.

(only for the students passing out in 2022, 2023, 2024)

Candidates who appeared in the 2024 H.S Examination need to secure the minimum percentage of marks indicated under the Eligibility criteria for the confirmation of admission.

Failure to pay fees within the specified timeframe will result in the imposition of fine of Rs. 500/- if paid within 10 days from the specified time frame and thereafter Rs. 500 plus Rs. 20/- per day.

■ RULES AND REGULATIONS

1. Students must attend a minimum of 75% of all classes, including moot court exercises, tutorials, and practical training, in order to be eligible to take the end-semester examination.
2. No student will be allowed to enter the institution without wearing the prescribed uniform.
3. The institution maintains a zero-tolerance policy towards ragging, and individuals found engaging in such activities will face disciplinary action in accordance with UGC guidelines.
4. The institution is committed to providing a harassment-free environment, and any instances of sexual harassment will be dealt with according to established guidelines.
5. Smoking is strictly prohibited on the entire campus premises.
6. The use of mobile phones during class is prohibited, except under the explicit guidance of the respective class teacher.
7. Loitering in and around the campus during class hours is strictly prohibited, and offenders will be subject to appropriate penalties.
8. Failure to pay fees within the specified timeframe will result in the imposition of fines.
9. Students are required to comply with all rules and regulations set forth by the UGC, the University of Kalyani, and the institution's authorities.
10. Students are expected to maintain decorum within the college premises, which includes showing respect towards faculty and staff; any instances of misconduct may result in disciplinary measures being taken by the college.
11. Punctuality is expected of all students, and they should ensure they arrive on time for their classes.
12. Students are expected to refrain from engaging in any activities that may disrupt the smooth functioning of the college.
