Aerie 3482 Rules

1. Per Aerie & State rules, alcoholic beverages are served to members & their guests. If you bring a guest they must be signed in by you and you ARE responsible for them the entire time they are in the club and they must leave with you when you leave.
2. Alcoholic beverages may be purchased by members only, age 21 and over.
3. Bartenders have the right to refuse service to anyone at any time! If you are asked to leave you have 5 minutes to leave or 30 days to think about it.
4. You must carry your dues card at all times while in the Aerie and present it when asked. Otherwise you must sign in.
5. If you are a member of this Aerie or Auxiliary and ring the bell, you must present your card before you are served. You may not give your card or dues card to anyone else to use.
6. Please have fun and enjoy yourself.

Auxiliary Interviewing Committee

First we would like to thank all our Auxiliary Sisters for the diligent efforts to sign up new members. Your efforts are greatly appreciated. We would like to review our process for Interviewing. All Applications must be read on the Floor of our meeting twice. After the first reading the prospective member is contacted to set up an Interview. This entire process takes about 4-6 weeks depending on the timing of the first "Read on the Floor" & the Applicant's availability for Interview. We do have one request of the "First Proposer" when taking the application. Please confirm with the Applicant their phone number & email address [if applicable]. Again thank you all for your continuing efforts to encourage and take new applicants into our Auxiliary.
