This letter is meant to provide you with important information regarding 2021 updates and plans for 2022. Lake Milton Estates Property Owners Association, Inc. is a non-profit property owner's association formed in 1973. Our mission is to preserve, protect, and enhance the lifestyle, property values, environment, and reputation of Lake Milton Property Owners Association as a controlled access community. Our organization serves our members by enforcing by-laws, making community improvements (roads, signs, lawn/tree maintenance), and ensuring the safety of our community.

#### Safety

Safety is our top priority. During the summer months there are a lot of people that come to visit our beautiful development, enjoy golf cart rides, ATVs, and boating. For those of you that have guests, please remind them to SLOW DOWN. Our speed limit in the allotment is 10 MPH. We set this limit to control the dust that gets thrown on our houses, but more importantly, to reduce the risk of accidents. Going too fast makes it difficult to stop quickly on our gravel roads. Be on the look-out for golf carts and ATVs. Our members are good about obeying the speed limit. Please inform your guests of the speed limit to help keep our community safe. If operating vehicles at night, please make sure vehicles have appropriate safety equipment such as reflectors and lights.

#### **2021 Recap**

The annual meeting was held on 9/12/2021 at 11AM. Meeting minutes can be found at lakemiltonestates.com. 2021 was an election year and those in attendance voted for officers and trustees. The result of the election is as follows: **President** – Keith Glaros, **VP** – Bill Leone, **Secretary/Treasurer** – Vincent Gallo, **Trustees** – Jim Gioppo, Tom Hubble, Tom Bleggi, John Ragan, Penny Stratos.

We had a successful Spring work party. Members of our community helped pick up trash, remove debris from ditches, and repair roads. Thanks to all that donated their time and equipment. The spring work party is a great way to connect with your neighbors while making neighborhood improvements.

Road maintenance continues to be our top priority. In 2021 we tarred and chipped Gateway. This maintenance is generally due every 3 years. This was our largest expense in 2021 (\$6700). We continue to repair roads. The use of the box blade on the tractor has reduced the expense of new gravel. The box blade brings existing material to the surface. We came in under budget in 2021 for new gravel.

#### Other 2020 accomplishments:

- The association continues to pay Keith Glaros \$500 annually for access and use of tractor for allotment purposes. The association is also paying for Diesel fuel costs. The box blade has produced excellent results on the gravel roads. It's reduced the amount of new material that is needed per area.
- Canton Drive received a base coat of gravel
- Akron Drive gravel was donated by Tom Hubble (Thank you)
- Ravenna repairs were completed
- Youngstown and Greenville received new gravel
- Culvert Repair on Youngstown was completed.

#### PLEASE READ

Reminder for boat ramp lock. Only paid members have access and have been given combination. Please remember to lock gate after use. In April, the trustees will be changing the combination of the dock ramp. Once you have paid your 2022 dues, the officers will communicate the combination to you. #### <u>Dues – Remit by 6/1/2022</u>

Dues will not increase in 2022. Dues schedule below:

- 2022: \$200 for owners with houses, \$150 for land only owners (dues by 6/1/2022)
- 2023: \$200 for owners with houses, \$150 for land only owners (dues by 6/1/2023)

Dues are used to maintain roads, equipment repair, fuel, taxes, improvements, and legal fees (if needed). If you would like a receipt for your dues payment, please provide a request when your dues are paid.

2022 proposed improvement projects are listed below. The officers and trustees will vote and prioritize the projects based on available funds. If you have any suggested improvement projects, please contact us.

- Gravel for roads/pot holes. Gravel purchases are generally done in May and early June. We have allocated \$6000 for 2022 for new gravel. Many of our main roads will only need minor repairs as we have been keeping up well with the maintenance. We are going to focus efforts and funds to some roads that have minimal to no gravel on them currently
  - o Canton
  - o Pittsburgh
  - Youngstown
  - o Ohio Dr
- Culvert on Ohio Court and Youngstown
- Culvert repair on Sebring
- New street signs where needed
- Continue addressing other drainage issues (if funds allow)

For those of you that pay each year, we would like to thank you for your continued support. For those that are past due or have not paid, we are asking that you pay your dues promptly. It's important that we all do our fair share to keep our community beautiful.
