# ARTICLES OF INCORPORATION OF COLLINS PLACE HOMEONWERS ASSOCIATION, INC.

Be it known, that on this 21th day of 100 member 2006, before me, the undersigned Notary, duly commissioned and qualified in and for Parish, Louisiana, appeared several parties over the age of 18 whose signatures are subscribed, and who declared, in the presence of the undersigned competent witnesses, that in accordance with the provisions of La. R.S. 12:201 to 12:269, they hereby organize a nonprofit corporation under and in accordance with these articles of incorporation.

#### ARTICLE I

#### NAME

The name of the corporation is COLLINS PLACE HOMEOWNERS ASSOCIATION, INC.

## **ARTICLE II**

## NONPROFIT CORPORATION

Collins Place Homeowners Association, Inc. is a nonprofit corporation.

## **ARTICLE III**

## **PURPOSES AND POWERS**

This corporation is organized exclusively for the purpose of furthering the common good and general welfare of the people of the community, and for bringing about civic betterment and social improvements. All lot owners will be entitled to membership in the corporation. The corporation will encourage plans and programs calculated to better living conditions in Parish, and will assist and distribute information to empower, to participate, or to intervene in political

campaigns on behalf of or in opposition to any candidate for public office. No person who is a candidate for or who holds any political office or appointment not within the civil service system, excluding an honorary appointment or position for which no renumeration is paid, will be eligible to be an officer or member of the board of directors of this corporation. This corporation will have and enjoy all of the powers which may be possessed by a nonprofit corporation, but subject to the limitations that the corporation will not have or exercise any power which may not be vested in or exercised by a corporation qualifying under Section 501 of the Internal Revenue Code (26 U.S.C.A. § 501), as it may be amended from time to time.

## ARTICLE IV

## **DURATION**

The corporation will enjoy perpetual existence.

## **ARTICLE V**

## **REGISTERED OFFICE**

The name of the registered agent of the corporation is Amanda Benton and the address of the registered agent for the registered office of the corporation is 1208 S. Range Avenue, Denham Springs, LA 70726.

## **ARTICLE VI**

# **BASIS OF ORGANIZATION**

This corporation will be organized on a nonstock basis. Membership in the corporation will be determined in accordance with the bylaws of the corporation.

#### ARTICLE VII

## **BOARD OF DIRECTORS**

The direction and administration of this corporation will be vested in the board of directors. The number of directors and their terms and qualifications will be specified in the bylaws.

## ARTICLE VIII

## **DUES AND ASSESSMENTS**

Each member of this corporation must pay such dues and assessments as may be required by the bylaws and action of the board of directors. The board may from time to time adopt such policy for the expulsion and reinstatement of members on account of nonpayment of dues and assessments.

#### ARTICLE IX

## **BYLAWS**

The members or the directors will have the power to make, amend, and appeal bylaws to govern this corporation.

## **INCORPORATORS**

The incorporators of this corporation are the above-named.

## ARTICLE XI

# DISTRIBUTION OF ASSETS ON DISSOLUTION

Should this corporation ever be dissolved, or should its existence terminate, all the assets of the corporation must be distributed only to organizations exempt from income tax under the provisions of Section 501 of the Internal Revenue Code (26 U.S.C.A. § 501), or to the federal, state, or local government for a public purpose. No part of the assets of the association must ever be distributed to or used for the benefit of any member, trustee, or officer of the association. or any private individuals or corporations.
