BEACH CLUB RULES AND REGULATIONS

Summer Season Hours: 9:30 a.m. to 9:00 p.m.

All Summit Village Association (SVA) Beach Club guests are expected to observe and follow the Beach Club rules and regulations listed below while visiting the Beach Club. Failure to do so will result in loss of Beach Club privileges. The rules are designed to provide a safe and pleasant environment for everyone. Beach Club attendants have been asked to report any offenders to the Beach Club Chairperson.

WHO MAY ENJOY THE USE OF THE BEACH CLUB

1. All Summit Village home, condo, or lot owners in good standing, and members of their immediate family.
2. Rental guests, of Summit Village home and condo owners in good standing.
3. Fisherman's Paradise lakefront property owners with an ID card, and their guests.
4. VPN Timeshare Owners staying at Summit Village may visit the Beach Club providing they have a pass confirming the dates of their stay in Summit Village. These guests, however, may **not** reserve the Clubhouse or Pavilion.

The Beach Club is not for the use of Schuss Village or Cedar River Village property owners Resort guests, or Summit Village Lake View Resort guests.

RULES TO BE OBSERVED WHILE USING THE BEACH CLUB

1. The Beach Club is a **NON-SMOKING ENVIRONMENT**.
2. **NO PETS** are permitted on the premises.
3. Guests must show their property ID card or pass, and sign in at the Beach Club entrance each visit. Guests must be accompanied by the SVA property owner.
4. Respect the Beach Club attendants. They are there to help. If advised of rules or regulations, please follow their suggestion.
5. Swim at your own risk. **NO LIFEGUARD IS ON DUTY**.
6. No swimming in the boating area. No boating in the swimming area.
7. No water skiing from either the dock or the raft.
8. **Motorized personal watercraft are not allowed anywhere in the Beach Club area.** This includes swimming, shore station, and boat mooring areas.
9. Cooking is restricted to grills only.
10. Park in the designated parking lot. The vacant lot behind the parking lot is for overflow parking only.
11. Guests are responsible for their own possessions and for cleaning up their area.
12. **Summit Village Association assumes no responsibility for loss or damage to boats or personal property.**

DAY BUOY RENTALS

1. Home, condo, or lot owners may rent day buoys for their own personal use. Only one day buoy may be rented per owner at any one time. Multiple owners of a single property will be treated as one owner. **Property owners that are assigned a boat slip may not rent a day buoy.**
2. VPN Timeshare Owners will be given the opportunity to rent day buoys that remain unreserved 14 days prior to a desired rental period. All requests must be submitted in writing and must be accompanied by evidence of timeshare ownership in Summit Village. The Beach Club Supervisor will maintain a waiting list for such requests, and honor them on a "date received" basis.
3. Day buoys shall be booked through the Beach Club Supervisor or by request forms available online. A fee of **\$15.00 per day** must be paid in full at the time you request the buoy. A buoy may be reserved for up to 7 consecutive days. There must be at least 5 days between any 7-consecutive day rental, and no more than 2 weekend rentals will be allowed in a 30-day period.
4. All boats should be removed by 10:00 a.m. the day after your reservation ends.
