Our management company, The Bellaire Professional Centre LLC, handles the complex and pool management according to our Deed Restrictions and Bylaws with direction from the board. This includes exchanging information for board decisions, managing community improvement projects, and conducting business as directed by the board.

Snowshoe condominiums are part of the Summit Village Association (SVA), which manages roads, grounds, building sites, certain community rules, Shanty Creek Resort internet, and the Beach Club on Lake Bellaire. SVA dues are included in the owner's monthly assessment. The SVA holds an annual meeting in September for owners. More information about the Summit Village Association visit svashantycreek.org.

Finances

The association finances are based on required monthly dues paid by the owner of each unit. Current monthly dues are: Studio/Lofts: \$342, Two-bedroom units: \$439, Three-bedroom units: \$528.

Dues are invoiced on the 1st of each month and should be paid to SnowShoe Association and sent to Bellaire Professional Centre, PO Box 332, Bellaire, MI 49615. Automatic monthly withdrawal or payment by credit card is not available.

Community Guidelines

- Noise Control: Keep noise to a minimum, especially between 8:00 am and 9:00 pm.
- Parking Regulations:
 - Each unit has one perpendicular parking space. Parking multiple vehicles is not permitted.
 - Trailer parking is not permitted in the Snowshoe lot.
 - Guest and trailer parking is available at the lot located above Snowshoe condos.
 - One parking space near the pool is reserved for Ridewalk owners during pool use.
- Pet Policies:
 - o Pets must be leashed outside.
 - Clean up after pets.
 - Avoid constant barking, particularly when pets are unattended.
- Trash and Recycling:
 - Use designated bins for household trash.
 - o Recyclables should be taken to the Antrim County Transportation Building.
- Mail and Packages:
 - No mail delivery at Snowshoe.
 - Deliveries should be done only when the owner is present.
 - Use the downtown Bellaire post office for mailboxes.
- Property Maintenance:
 - Owners maintain decks and stairs.
 - o Exterior modifications need HOA approval.
 - No grilling on decks; use shared outdoor grills.
 - No propane tanks, firepits, firearms, or fireworks.
 - Avoid smoking.
 - Common storage (building 4) is for labeled (unit #) seasonal items.
 - Be respectful of shared spaces and clean up after use.
- Safety and Security: Lock windows and doors when not in use. Report suspicious activity.

Amenities and Pool

- Access to SnowRidge pool is for SnowShoe and Ridgewalk owners and guests only.
 - Open 9:00 am to 10:00 pm from Memorial Day to Labor Day.
 - No lifeguard; swim at your own risk.
 - Follow pool rules (no glass, no running, no diving, accompany children, etc).
 - Keep the pool area and unisex restroom clean.
 - The pool is maintained by Bellaire Professional, following state requirements.
- Access to Pinebrook pool and Summit Village Association Beach Club on Lake Bellaire are available for Snowshoe owners and guests. (both off M88)
 - Beach Club entry requires an SVA membership card (obtained at the club) and arrangements must be made for renters. (5597 Northlakes Rd, Bellaire, MI 49615)
 - The Beach Club is open 9:30 am to 9:00 pm Memorial Day to Labor Day.
- Various outdoor activities at Shanty Creek Resort such as golf, skiing, and tubing are available throughout Shanty Creek Resort. For more information visit shantycreek.com.
