- 8. All drivers must exit the truck and enter scale house inbound and outbound.
- 9. It is the driver's responsibility to review data on final ticket for correctness. The hauler will be held liable for damages due to incorrect data provided.
- 10. If your equipment is damaged during the unload process, notify the scale house and complete the damage assessment form BEFORE LEAVING OUR FACILITY.
- 11. Triple J Tie & Timber, LLC has a zero tolerance policy for wood theft. Confirmed cases of wood theft will result in permanent ban of all parties involved.
- 12. By entering our yard, you personally agree to consent to a drug and alcohol test if you are involved in an incident while on our yard.
- 13. If you see something unsafe on our yard, say something. Contact the scale house at 662-547-6600.
- 14. In the event of an emergency, dial 911.
