

RB&CC visits Saratoga Springs, NY in 2024 Bruce Rodman

Hello everyone I've done some preliminary research about an RB&CC trip next summer to Saratoga Springs, NY & here are some thoughts.

Dates: Wednesday and Thursday nights, July 31 to August 1, 2024 (there is no racing on Mondays or Tuesdays, and weekends are challenging for dining and track reservations).

Accommodations: Several options, which would probably be left up to the individual members to make their own reservations. Several of the newer properties downtown are already sold out, but the Saratoga Hilton (downtown) is available for about \$400 per night. About 20 minutes south of Saratoga is the Hampton Inn of Clifton Park, NY for about \$215 per night. There are other options but probably not much else downtown.

Activities: Arrive **Wednesday** July 31 by noon, lunch downtown, which I could reserve. After lunch, a visit to the National Museum of Racing and Hall of Fame on Union Avenue, Saratoga Springs. Walking tour of downtown or catch the late races across the street. Dinner, which I would arrange.

Thursday: Arrive at Saratoga Racecourse around 7:30am for backstretch tour hosted by me as your tourguide, followed by breakfast on your own. 1PM -- attend the races at the oldest thoroughbred racetrack in the Americas, seating about \$50 per person to be arranged by me. Dinner, which I would arrange.

Friday: Depart

Arranging accommodations is the trickiest part -- my thinking is that each member would make his own reservations. I could try to get group rates and, if successful, communicate that info to interested members. The only thing that would be a "group" expense would be seating at the track, which I could front, and members reimburse me. Everyone could pay their own Museum fee, and the backstretch tour is free. Nonmembers are welcome, too.

Bruce Van Vliet July 13, 1934 - Nov. 17, 2023 (Long time member of RB&CC)

Bruce Van Vliet of Vero Beach, Florida, passed away Nov. 17, 2023. The younger of two boys, Bruce was born July 13, 1934, in Orange. He grew up in West Orange, attending grammar and high school at Newark Academy. He continued his education at Lehigh University as a member of the ROTC. After graduating college, he joined the U.S. Army and spent several years reconstructing airfields in Japan and Korea, retiring as a lieutenant.

After the Army, Bruce branched out on his own, starting up companies with a focus on engineering. His work ranged from industrial clean rooms and soundproofing to cogeneration and industrial HVAC, and took him from the top of the World Trade Center to Puerto Rico. Bruce was also a frequent guest lecturer at the former Newark College of Engineering.

In his youth, his summers were spent at the Jersey Shore, sailing at Mantaloking Yacht Club or swimming in the ocean. He had a passion for sailing which continued throughout his entire life. Not one to sit still, he was an accomplished skier and eventually became a private pilot. Bruce was an active racquet sports player, loving squash, tennis and paddle tennis. In 1977, Bruce moved to Rumson from Short Hills to be near the ocean he loved, and there he continued his passion for sailing and playing racquet sports.

One fateful day — Sept. 9, 2012 — he suffered cardiac arrest while playing tennis. Thankfully, he was playing with three Marines and they knew exactly what to do until the police and EMS arrived. After three long and arduous days in the ICU, he awoke and began his road to recovery. Monmouth Medical Center called Bruce the Miracle Man, a title he gladly accepted. He was well known in the medical circles of Monmouth County for surviving this trauma to his heart. At the age of 78, not many people could have survived, but the skilled hands of his doctors gave him another 11 years of precious life.

Bruce was predeceased by his parents Virginia and Ira Merril Van Vliet; his brother Neil Van Vliet; and his son -in-law Jack Gerber. He is survived by his adoring wife Diane, his biggest fan and advocate; his six children, Frank Semcer and Tina Gill Semcer of Chester, Paige Semcer McCann and David McCann of Rumson, Brian and Christine Semcer of Summit, Suzanne and Michael Taddeo of Syracuse, New York, Lyndsey Van Vliet of Chevy Chase, Maryland, and Heidi Barazza of Melrose, Massachusetts; his grandchildren, Trey, Carly and Kiera Semcer, Olivia Anagnostis, Connor and Ryan McCann, Jake, Mackenzie and Cooper Semcer, Sarah (Dan) Eager, Steven (Alicia) Taddeo, Amanda, Bradford (Lyndsey) and Clayton Gerber; his great-grandchild Micah Taddeo; and, of course, his best buddy, his dog Brody.

Bruce was a member of Navesink Country Club in Middletown; Monmouth Beach Bath and Tennis Club in Monmouth Beach; and Orchid Island Golf and Beach Club in Vero Beach. He was also a parishioner of Holy Cross Church in Rumson and of Holy Cross Church in Vero Beach.

A memorial service took place at 11 a.m. Dec. 29 at The Church of the Nativity, 180 Ridge Road, Fair Haven. In lieu of flowers, please consider a donation to either the Humane Society of Vero Beach, 6230 77th St., Vero Beach, FL 32967 (hsvb.org) or Tunnel to Towers Foundation (t2t.org).

A Presentation by General George Washington – 12/19/23 by Sam Davis, President of the Morrisville, PA Historical Society

While the Continental Congress was meeting in Princeton, Rockingham, NJ, a home first known as the Berrien Mansion, served as General George Washington's final Revolutionary War headquarters for over two and one-half months in 1783. On October 31, 1783, Washington and Congress received the long-awaited news that the final version of the Treaty of Paris officially ending the war had been signed and the thirteen colonies were indeed independent of Great Britain. Following the reading at Nassau Hall one of his officers said to him, "General, you look tired." He answered ….

So, you're right. I am. I'm tired and I don't feel well whatsoever. So, we walked into the house. And I looked at myself in the mirror, and I thought about what my officer said, and he was right. I did not look well.

Then I started to think back. When I first started, The revolution in 1775. I was a very handsome man. Very strong. Then things happened. The things that happened during those times took life out of my body. And it took a toll on me. And the toll was seeing my men for those eight years starving. Many of my men as you know, at Valley Forge, many were without shoes. They were starving at times. They were starving so badly that they would eat their dogs. And then they would eat the bark off the trees.

And I saw this. And it took life out of me. It was very, very horrible for me to see this. To see my brave men fighting for freedom and liberty and then suffering as they did. All I could do was write to congress to ask for food, supplies, and clothing. Many of my men were almost bare. And then the winter wind came, and they were freezing. And they were putting up tents. And pots. And the stench. So many of my men did not take a bath for weeks. They were suffering. And now they were asked to fight.

I remember when we crossed the Delaware River and were walking to the town of Trenton. And at that time, there was a nor'easter bearing down on us. And the sleet and the snow and the cold. It was horrible. And so many of my men did not have any shoes. They would wrap rags around their feet. To protect them from the ice. But so many times the ice would pierce through those rags and into my men's feet. And they were dropping blood on the ground so much so that I saw this as they went. They were dropping blood, patriots' blood, that time can never wash away. So, I continued to write to congress for help. And it always fell on deaf ears. (*cont*.)

But then, it goes on. In the battles of Trenton and Princeton my men would be out in the fields, fighting the Hessians and the British and many were left dead on the field. At the end of the battle, we had to move quickly because the enemy would be right on our tails, so we had to leave the field. And my men would still be there. Laying there, dead without a proper burial. And what would happen to them? Well, the vultures and the wolves would tear at them. Years later the bones would still be there on the ground.

They would never receive a proper burial or be identified later by wives and children. What happened to my father? What happened to my husband? What happened to my son? Never to come home. Never to return. And all. The way through the lives of the mothers. Children. The wives. They would never know whatever happened. Even to this day. So many of the men. The Revolutionary War was like no other. No communication. No identification. Nothing. My brave men who won the Revolutionary War. Those men. Need to be remembered. Forever.

We in this time don't understand what they want through. The torturous times. The winter of 1780 was the worst winter on record. The snow was as high as the roofs. My men. Gave it all. They gave it all. They suffered. They sacrificed and then they died. I'm sorry to leave you with those words. But these are the words that we all should remember. We have the glory of successfully winning the revolution. What exactly did the men go through? That is what we really need to remember. We need to remember in our souls, not only for the men, but also for the women. I will always say without the women of the revolution, we would have been in trouble. I truly believe that the women were the backbone of the revolutionary War. *(cont.)*

A Presentation by General George Washington – 12/19/23 by Sam Davis, President of the Morrisville, PA Historical Society

General Washington (Sam Davis) then said he would present a book on The Revolutionary War Trail to the person who asks the best question, and there were many.

How old was General Washington when he passed away? I was 67 years old. Born February 1762, I died December 14th, 1799, right before the next century which I missed by a few days. After working on the plantation (Mount Vernon) in the rain I came down with a very bad strep like aliment called Quinsy. My doctors bled me as was common at that time. My last request was a kiss from my wife Martha.

Was the American victory (Sept/Oct 1777) at the Battle of Saratoga a turning point in the Revolutionary War? Great question! Who asked that? I say it was it was the "tipping" point because France finally came to the realization that we might have the ability to win and decided to support our cause. The "turning" point of the American Revolution was the crossing of the Delaware into New Jersey for the Battle of Trenton, the second Battle of Trenton (a.k.a. the Battle of Assunpink Creek), and the Battle of Princeton.

"It may be doubted whether so small a number of men ever employed so short, a space of time with greater and more lasting results upon the history of the world" (Travillion, a British Historian). At the end of the Battle of Yorktown, Cornwallis surrendered. And when he surrendered, we had a ceremonial dinner as was customary. We had a long table with our foreign generals seated around me and the British General Cornwallis at the other end. We toasted each other and when it was General Cornwallis's turn to make a toast to me, he stood up with his glass held high in the air and said: "When the illustrious part of your excellency is born on the long and arduous contest as a matter of history, fame will gather your brightest laurels from the banks of the Delaware River." Cornwallis knew that the crossing of the Delaware River and the three battles that followed was the turning point of the American Revolution. If it wasn't for those 10 days would there have been anything else? It would have been over.


General Washington also answered questions on the size of his army/militias, their enlistments, troubles with his generals, and other battles such as White Plains, Camden, and the escape from Brooklyn into Manhattan and ultimately over to NY/NJ/PA.

Thank you, General Washington (Sam), for taking the time from your busy schedule to give a presentation to our group! Entertaining any public office aspirations?
