MILLER SIXTY-SEVEN TOWNHOUSES CONDOMINIUM ASSOCIATION, INC., a Florida corporation not-for-profit
(hereinafter referred to as the "Association").

RECITALS

WHEREAS, the Association has been established for the operation of Miller Sixty-Seven Townhouses, A Condominium, in accordance with the Declaration of Condominium and related documents which were recorded on March 1, 1974 in Official Records Book 8611, at Page 1834 of the Public Records of Miami-Dade County, Florida, and all exhibits and amendments thereto (the "Declaration").

WHEREAS, the Association's Articles of Incorporation are set forth in Exhibit "D" to the Declaration (the "Articles").

WHEREAS, in accordance with Article XV of the Association's Articles of Incorporation, the proposed amendment to Article XV of the Articles was proposed for adoption and approved by the affirmative vote of not less than a majority of the Board of Directors at a duly noticed meeting of the Association's Board of Directors held on May 12, 2021.


WHEREAS, at a duly noticed Reconvened Special Meeting of the Members held on June 17, 2021, at which a quorum of the Members was attained in person and by proxy, the proposed amendment to Article XV of the Articles of Incorporation was approved by in excess of seventy-five percent (75%) of the Members in accordance with Article XV of the Association's Articles of Incorporation.

NOW THEREFORE, the Association does hereby state as follows:

1. The above Recitals are true and correct and are incorporated herein by reference.
2. The duly adopted amendment to Article XV of the Articles was filed by the Florida Secretary of State's office on August 3, 2021, and a copy of said Articles of Amendment are attached hereto and incorporated herein as Exhibit "A".

**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
MILLER SIXTY-SEVEN TOWNHOUSES CONDOMINIUM ASSOCIATION, INC.**

1. The Articles of Incorporation of Miller Sixty-Seven Townhouses Condominium Association, Inc., a Florida corporation not-for-profit (the "Association"), created pursuant to Chapter 617, Florida Statutes, were filed on January 9, 1974, and assigned Florida document number 728623.
2. Pursuant to the provisions of Section 617.1006, Florida Statutes, the Association adopts the following Articles of Amendment to its Articles of Incorporation.
3. New Language is indicated by underlined type.
Deleted language is indicated by ~~struck-through~~ type.
4. Article XV of the Articles of Incorporation is hereby amended as follows:

An Amendment or Amendments to these Articles of Incorporation may be proposed by the Board of Directors of the Corporation acting upon a vote of the majority of the Directors, or by the members of the Corporation owning a majority of the Condominium Units in the Condominium, whether meeting as-members or by instrument, in writing, signed by them. ~~Upon any amendment or amendments to these Articles of incorporation being proposed by said Board of Directors or members, such proposed amendment or amendments shall be transmitted, to the President of the Corporation or other Officer of the Corporation, in the absence of the President, who shall, thereupon, call a Special Meeting of the Members of the Corporation for a date not sooner than fifteen (15) days, or later than forty five (45) days from the receipt by him of the proposed amendment or amendments, and it shall be the duty of the Secretary to give to each member written or printed notice of such Meeting, stating the time and place of the meeting and reciting the proposed amendment or amendments in reasonably detailed form, which notice shall be mailed or presented personally to each member not less than ten (10) days, or more than thirty (30) days, before the date set for such meeting. If mailed, such notice shall be deemed to be properly given when deposited in the United States mail, addressed to the member at his post office address as it appears on the records of the Corporation, the postage thereon prepaid. Any member may, by written waiver of notice signed by such member, waive such notice, and such waiver, when filed in the records of the Corporation, whether before or after the holding of the meeting, shall be deemed equivalent to the giving of such notice to such member. At such meeting Thereafter, the amendment or amendments proposed must be approved by an affirmative vote of a majority of the members of the Association represented in person or by proxy at a meeting of the members the members owning not less than seventy-five (75%) percent of the Corporation in order for such amendment or amendments to become effective. Thereupon, such amendment or amendments of these Articles of Incorporation shall be transcribed and certified in such form as may be necessary to register the same in the office of the Secretary of State, State of Florida, and upon the registration of such amendment or amendments with said Secretary of State a certified copy thereof shall be recorded in the Public Records of Miami-Dade County, Florida, within ten (10) days from the date on which the same are so registered. At any meeting held to consider such amendments of these Articles of Incorporation, the written vote of any member of the Corporation shall be recognized, if such member is not in attendance at such meeting or represented thereat by proxy, provided such written vote is delivered to the Secretary of the Corporation at or prior to such meeting.~~


Notwithstanding the foregoing provisions of this Article XV, no amendment to these Articles of Incorporation which shall abridge, amend or alter the rights of MILLER SIXTY-SEVEN CORPORATION to designate and select members of each Board of Directors of the Corporation, as provided in Article VIII; hereof, may be adopted or become effective without the prior written consent of the said MILLER SIXTY-SEVEN CORPORATION.

No amendment to these Articles of Incorporation shall be adopted which would operate to prejudice or impair the right or privileges of any institutional first mortgagee as such rights and privileges have been established in the Declaration of Condominium of MILLER SIXTY-SEVEN TOWNHOUSES, a Condominium, Miami-Dade County, Florida.


