Terms and Conditions for Westmoreland City Volunteer Fire Department Online Vehicle Raffle

The following Terms and Conditions govern the Westmoreland City Volunteer Fire Department ("WCVFD") Online Vehicle Raffle. By purchasing a ticket for the raffle, you agree to abide by these rules and regulations.

1. Organizer

The Westmoreland City Volunteer Fire Department (WCVFD) is the sole organizer of this raffle. All inquiries regarding the raffle should be directed to WCVFD.

2. Eligibility

- The raffle is open to all individuals aged 18 or older who are residents of the United States of America.
- The grand prize winner must be able to meet at the participating dealer in person to take possession of the vehicle. No grand prize vehicles will be shipped / delivered.
- The winner must be 18 years of age or older. If the winner is not 18 years of age or older, a new winner will be determined by the next **Pennsylvania Evening Pick Three Lottery** ("PA Evening Pick Three Lottery") drawing that takes place after WCVFD identifies that the original winner is under 18 years of age. This re-drawing day will be advertised / communicated 24 hours prior to the drawing date.
- The winner must be a resident of the United States of America. If the winner is not a resident of the United States of America, a new winner will be determined by the next **Pennsylvania Evening Pick Three Lottery** ("PA Evening Pick Three Lottery") drawing that takes place after WCVFD identifies that the winner is not a resident of The United States of America. This re-drawing day will be advertised / communicated 24 hours prior to the drawing date.
- WCVFD members and their immediate family members are eligible to purchase tickets and win the raffle. The term "immediate family" includes parents, spouses, children, siblings, and household members.
- Raffle participants must comply with all local, state, and federal regulations.

3. Ticket Sales

- A total of **1000 tickets** will be sold for the raffle.
- Each ticket will be assigned a unique three-digit number, ranging from 000 to 999.
- Tickets will be sold online through the WCVFD's chosen authorized platform.
- The price of each ticket will be clearly stated during the purchase process.
- All ticket sales are final and non-refundable unless refunded at the discretion of WCVFD.
- In the event that more tickets are sold beyond the designated predefined number of changes, WCVFD will notify and refund the purchase of the oversold tickets.

4. Drawing and Winner Determination

- The winning ticket number will be determined by the **Pennsylvania Evening Pick Three Lottery** ("PA Evening Pick Three Lottery") drawing that takes place within 5 days after all tickets are sold and after WCVFD has posted all ticket numbers and names with the day of the drawing advertised.
- The **three digits** of the PA Evening Pick Three Lottery number will be used to determine the winning ticket number. For example, if the PA Evening Pick Three Lottery number is **123**, then the ticket number **123** will be the winning ticket.

5. Prizes

- **Grand Prize:** The holder of the winning ticket number will receive the vehicle currently being raffled.
 - Substitution of the as advertised vehicle to a different vehicle of equal value is at the discretion of the participating dealer.
 - Actual price vehicle may differ, however the value of the vehicle will remain equal to as advertised.
- **Monetary Prizes:**
 - The holders of the ticket numbers directly above and below the winning ticket number will receive a monetary prize, the amount of which will be defined by WCVFD and clearly advertised before ticket sales begin.
 - Example: If the winning ticket number is **123**, the ticket holders for **122** and **124** will each receive the pre-determined monetary prize.
 - The holders of the ticket number in reverse order of the winning ticket number will receive a monetary prize, the amount of which will be defined by WCVFD and clearly advertised before ticket sales begin.
 - Example: If the winning ticket number is **123**, the ticket holder for **321** will each receive the pre-determined monetary prize.
- All winners will be notified as specified in section 6.

6. Winner Notification and Claiming the Prize

- Winners will be notified by email or phone within **48 hours** of the PA Evening Pick Three Lottery drawing.
- If the winner cannot be reached within **30 days**, the prize may be forfeited, and an alternate winner will be selected.
- The grand prize winner (vehicle recipient) must claim the vehicle within **30 days** of notification. The vehicle will be acquired by the winner at the predefined partnering vendor location as advertised.
- The winners of the monetary prizes will receive their prizes within **30 days** of the PA Evening Pick Three Lottery drawing via check.

7. Vehicle Taxes, Title, and Fees

- WCVFD will cover the **cost of tax, title, and registration fees** associated with the prize vehicle.
- The vehicle will be transferred directly from the dealer selected to the winner, who will be responsible for ongoing costs related to ownership, including insurance and maintenance.
- Winners of all other prize should consult their Tax preparer for further guidance.
- WCVFD is not responsible for any taxes or fees associated with monetary prizes.

8. Limitation of Liability

- WCVFD is not responsible for any injuries, damages, or losses incurred during the raffle process or upon receiving the prize.
- WCVFD is not liable for technical issues related to the online raffle platform, including but not limited to, payment processing errors or access issues.
- WCVFD is not responsible for any lost or undelivered communications.

9. Publicity

- By purchasing a ticket, the winner agrees to allow WCVFD to use their name, likeness, and other identifiable information in promotional materials for the raffle and other activities related to WCVFD. This may include online and offline promotions, but the winner will receive no additional compensation.
