- Family Day update

- On our last Family Day we had an amazing presentation by Suzette and Marlene about prescription medication and the consequences of misusing it. We also had snacks for the family and a good time to play and spend time together. We had around 35 members of the community. Next Family Day will be held by the Nogales Police Department, and the next months are open for any agency from the community to host it.
- Recovery Café update
 - Luis Gaxiola shared that the first Recovery Café was a success. He talked a little about what we did and how it helped him to feel more relaxed, more comfortable and more motivated to continue doing his job and working with partners from the community. The next Recovery Café will be held on March 16 at the Center for Restorative Youth & Community Programs, all treatment providers are welcome to join us.
- Naloxbox update
 - Channing shared that the Naloxbox kits were being placed on different areas of the community. Currently we have 4 placed and we are waiting for the approval from the Fire Department to place more in the community. Also, we are working on creating a map with the different locations of the kits for the community to have them on hand.
