Mayor Spell opened the regular board meeting at 7:30 pm. Mayor Spell led the pledge of allegiance and Commissioner Honeycutt said the prayer.

Commissioner Honeycutt suggested to keep the balance on Mr. Abdullah's account but remove Mr. Faircloth's account from collection.
