

# Town of Autryville Regular Board of Commissioners Meeting Minutes Tuesday, May 16, 2023 Autryville Town Hall

### 1. CALL TO ORDER / PLEDGE OF ALLEGIANCE / INVOCATION

Mayor Spell called the meeting into session at 7:30 pm and led the Pledge of Allegiance. Commissioner Honeycutt said the invocation.

#### **2. PUBLIC COMMENT**

This portion of the meeting is an opportunity for citizens to speak on any issue concerning the Town of Autryville. A total time limit of 15 minutes will be allotted for this portion of the meeting. Each speaker will have a maximum 3 minutes. The first five residents who sign up with the Town Clerk will have an opportunity to address the Board of Commissioners.

Commissioner Baker asked the board to forgive or provide a payment plan for her son John Baker's water bill, which was in excess of \$300. Because of consistent on time payments by the customer, the board decided to forgive the \$300 bill.

b. Hunters Stormwater Repair Presenter: Mayor Spell

Mayor Spell and Public Works Director Bullard will be working on the repairs with town equipment in good weather.

c. W Vinson Stormwater Repair Presenter: Mayor Spell

Mayor Spell is meeting with contractor and will have an estimate at the next meeting.

Southern Software has provided an invoice of \$1,250 to connect the PSN software with the financial software. Mayor Spell directed this to be postponed until the general fund budget is balanced.

g. Filing Deadline for 2023 Election Presenter: Mayor Spell

July 7-21<sup>st</sup> is the deadline for filing for reelection.

h. Facility Rental Agreement Deposits Presenter: Commissioner Tyndall

The Town of Stedman uses policy agreements for town park reservations with no charge. Mayor Spell said he will present a policy agreement to use in Autryville at a next meeting.

#### 9. NEW BUSINESS

a. Deer Run Lane Improvements Presenter: Mayor Spell

Mayor Spell received a quote to box blade a section of a town street of \$975 that is deteriorating. The board said they would like to receive more quotes.

b. Autryville Town Limit Signs Presenter: Mayor Spell

We are going to postpone this expenditure until the budget is balanced.

c. Town Hall HVAC System Maintenance Agreement Presenter: Mayor Spell

Commissioner Spell, who owns Spell Mechanical Services, recommended the money to be used to purchase a replacement HVAC, which services the conference room and is 25 years old. He will provide an estimate at the next meeting.

d. Annual Powell Bill Inspection Presenter: Mayor Spell



Millard Owen Surveying estimated \$2,000 to survey the streets for the required annual Powell Bill inspection.
