5. FINANCIAL REPORT

a. Budget vs. Actual Statements

Both the General Fund and Water Fund are in positive numbers.

b. Water Department Usage and Savings

Town Clerk reported 25% of customers are using PSN to pay utility bills, which has resulted in \$900 in savings.

6. GRANT REPORT

a. North Carolina Budget Earmark Request

The Town has received \$2 million for water infrastructure, \$900,000 for stormwater improvements, and \$150,000 for street paving.

b. ARP Stormwater Grant

This grant is 14% complete.

c. NCORR Grant for Local Government Services

This grant is 32% complete.

d. Asset Inventory and Analysis Grant

This grant is 25% complete.

7. STREET DEVELOPMENT & MAINTENANCE

a. Huntersview Stormwater Repair

No updates

b. Deer Run Lane Improvement

Mayor Spell suggested not improving Deer Run Lane until the street is paved with earmarked money.

c. W Old Stage Rd Stormwater Improvements

Mayor Spell proposed a plan that involves volunteer work from Commissioner Spell and Terry Spell. The town will be responsible for paying for one part, which is covered by the Powell Bill.

d. N Cooper St Stormwater Improvements

Mayor Spell has been speaking with McDonald to quote the repair.

e. Water Leak on E Clinton St

Fixing the leak decreased the town's water usage 10,000 gallons a day. The town is still using over predicted usage at 51,0000 gallons a day.

8. HOUSING & COMMERCIAL DEVELOPMENT

a. Horseshoe Road New Houses

Construction is starting soon.

b. Minnie Hall Road New Houses



All the houses are sold.

c. Sivertson Road New House

All houses are for sale.

d. Dollar General

Construction has began to build the new store on E Williams St and Hwy 24.

9. PUBLIC WORKS FACILITY

a. Development and Construction

Half an acre of land behind the water tower has been donated to the town for construction of the public works facility.

b. Alarm System

Mayor Spell presented a quote from Gill Security Systems to provide an alarm system to protect public works department equipment. Gill Security Systems currently provides security for Town Hall. Alarm System is wireless so when new public works facility is constructed, it can be moved.
