d. Mid-Carolina Regional Council Grand Administration Agreement Present Mayor Spell

Andrew White, an engineer from MCRC, explained that the agreement would enable him and his associates to help the town communicate with the state, hold records, reporting, and reimbursements from the state. He noted that the current funds left from the NCORR grant, which is approximately \$50,000, can be used to pay toward the agreement. The NCORR funds expire at the end of 2025. The mayor explained that once construction starts, reimbursements from the state to the contractor needs to managed heavily to avoid any issues.
