HART COUNTY ROAD SYSTEM AMENDING SECTION OF THE COUNTY ROAD SYSTEM

KOC 620.4A

An Ordinance Relating to the County Road System and Amendment Thereof.

WHEREAS, the Hart County Fiscal Court established a formal road system by county ordinances KOC 620.1 through 620.20; and

WHEREAS, The Hart Fiscal Court recommended changes in the system in regard to accepting a road into the county road system or rescinding a road from the county road system;

NOW THEREFORE, BE IT ORDAINED BY THE FISCAL COURT OF HART COUNTY, COMMONWEALTH OF KENTUCKY, THAT:

In order for a county road to be accepted into the county system, the road must have a total of 50 points based upon the following point system.

This system is replacing the following paragraph of the old section of KOC 620.4

Before any county road may be accepted into the county road system and in addition to the minimum standards, the road must serve a public purpose and in order to serve a public purpose or purposes, it shall meet three (3) of the five (5) following qualifications:

- a. Have three (3) occupied houses per mile.
- b. Be a mail route.
- c. Be a milk route.
- d. Be a school bus route.
- e. Serve as a farm to market road for cash crops.

This is being omitted and replaced with the following. However, this does not apply to subdivisions as defined in KRS Chapter 100 as subdivision roads are maintained as county roads under subdivision rules and regulations. This point system replaces any and all previous and prior ordinances relating to accepting roads into the county system.

- 5 points for each landowner served by the road.
- 5 points for each occupied residence.
- **5** points for each residence or land owner on garbage pickup.
- points for a handicapped child who uses the handicapped school bus.
 (Roads in this category are to be considered temporary public roads only and subject to temporary maintenance of gravel and grading.)
- .10 points for each licensed business, industry or agricultural related business.
- 5 points for each employee of that business, industry or agricultural related business (non-owner).
- **10** points for a milk route.

____ points for cemetery.

- (a) 30 points if a public (municipal or community) cemetery.
- (b) 20 negative points for an inactive family-owned or private cemetery.(no burial for last five years).
- (c) ____ points family cemetery active.

_____ points for an educational, religious or other institutions, societies, or

associations, whose sole object and purpose are to carry on charitable, educational or religious work.

- (a) 20 points without cemetery.
- (b) 30 points with cemetery.
- (c) 20 points contiguous to county road.
- (d) 30 points with day care and activity center in operation through the week.

Maximum point possible any or all combinations _____ points.

- **10** points for a mail route.
- **10** points for a school bus route.
- 50 points for each public building.
- **50** points for public access to a river, stream or public park. (negative points do not apply to this category)
- 20 (negative) points if only one landowner or residence served by the road.
