SUBJECT: Chestnut Grove Cemetery Road

Dear Judge Shelton:

As per your request, I have researched the approach to CR 1422, Chestnut Grove Cemetery Road and found that this roadbed was constructed along with a frontage road, KY 2756, when I-65 was built. We have no record that this approach was ever transferred to Hart County. Therefore, we would like the County to accept this 400' of roadbed into its County Road System. I have spoken to the office of Rural and Municipal Aid concerning the guardrail request on the approach. If the County accepted this roadbed, funds would be given to the County in order to construct the guardrail. A letter needs to be sent from the Fiscal Court to Steve Taylor, Director, 501 High Street, Room 118, Frankfort, Kentucky 40601 requesting payment for the guardrail construction. An estimate is attached showing the cost. Also, a Resolution is attached for signatures, if the County chooses to accept this offer.

Dear Judge Shelton:

This letter is concerning a possible trade of roads between the State and Hart County. Due to GPS Mapping, there was some confusion over ownership of a section of road off of US 31E in Bear Wallow. After much research we believe that this section of road is listed on the Hart County Road Series Map as part of (CR 1165). We agree that this section of road would best fit in the State System. *↳ Cave City - Bear Wallow Rd*

It is our policy to eliminate at least two miles of roadway from our system for every mile we take into our system. Therefore, we propose the exchange of the above mentioned section of road and KY 1358. It extends from KY 677 to KY 436, a distance of 1.647 miles. We realize that this road is in need of resurfacing. We would like the County to accept this roadbed into its system contingent upon completion of the resurfacing. Please review this road and our proposed trade. We feel this trade would move these roads into the appropriate systems. A map showing the location of these roads is attached.
