HART COUNTY ORDINANCE RELATING TO LICENSING AND BONDING OF
NON-RESIDENT ITINERANT MERCHANTS, PEDDLERS & PAINTERS

WHEREAS, the cities of Horse Cave and Munfordville
require a resident business to secure a license; and,

WHEREAS, the County requires licensing of places of
entertainment; and,

WHEREAS, itinerant merchants, peddlers and painters
come into the County and perform services or sell merchandise
and are unregulated; and,

WHEREAS, the Hart County Fiscal Court hereby finds that
the following occupations are of such a nature as to require
special regulations and supervision;

THEREFORE, the following minimum license fees are
imposed on every person engaged in the business, occupation,
calling or profession or using, holding or exhibiting
articles named in this section, who shall pay in advance
to the Hart County Fiscal Court for each calendar year or fiscal
year, or any fraction hereof, in accordance with the yearly
basis the license fee used in making a return under the terms of
this Article, the license fee or fees herein set forth which payment
shall be a credit on the license fee as otherwise provided in
this Article; however, where minimum fees are set forth in the
following table for a period of less than one (1) year, the

same shall be considered the minimum fee due for the period as set forth in such table and shall be paid in advance of engaging in such activity.

In the event a licensee engages in more than one (1) type of activity in one (1) business entity, the highest minimum license fee shall apply. Under column headed "Date Due" in the following table the words "Before Showing" or "Before Activity" shall mean as follows. "Before Showing" shall mean that the license fee per showing is due prior to the date of each showing and in the case of "Before Activity" it means that the license fee is due prior to each day of engaging in activity. Where the word "Yearly" appears under such column head, the same shall mean that the minimum fee shall be due on or before the first day of the taxpayer's accounting year as used in compliance with this Article.

Peddler, individual, who carries his merchandise with him while traversing the streets, sidewalks or alleys of Hart County for the purpose of exhibiting and selling such merchandise	\$ 5.00 per day per person	Before Activity
Painter, individual, who does not have a permanent business located in Hart County, Kentucky, but who engages in the painting of barns, houses or outbuildings	\$ 50.00 per year	Yearly
Hucksters (fruits, vegetables, and poultry)	\$ 25.00 per year	Yearly
Collection agencies	\$ 25.00 per year	Yearly
Lightning control equipment, sales or installation	\$ 50.00 per year	Yearly
Loggers and timber cutters and dealers who obtain timber contracts and assigns to others	\$ 50.00 per year	Yearly
Dealers in firearms or deadly weapons	\$ 15.00 per year	Yearly
Pawnbrokers	\$250.00 per year	Yearly


Before the Hart County Court Clerk's office shall issue a receipt to a peddler for his five dollar (\$5.00) per day fee to peddle, or to an itinerant merchant for his fifty dollar (\$50.00) fee per year, or the painter for his fifty dollar (\$50.00) fee per year or to a lightning control equipment sales or installation person for his fifty dollar (\$50.00) fee per year or to a logger, timber cutter or dealer for his fifty dollar (\$50.00) fee per year, they must file or have on file with the Hart County Court Clerk's office an approved indemnity bond issued by a surety company authorized to transact business within the Commonwealth of Kentucky. The term of the bond shall be for one (1) year. The bond shall be issued in the name of the peddler or itinerant merchant in the amount of two hundred fifty dollars (\$250.00) or the painter or the lightning equipment person in the amount of one thousand dollars (\$1,000.00) or the logger, timber cutter or dealer in the amount of five thousand dollars (\$5,000.00). A peddler, itinerant merchant,

painter, lightning equipment person, logger, timber cutter or dealer shall forfeit his bond to the Hart County Fiscal Court should he fail to comply with this Article. The Hart County Court Clerk's office is to charge for this service one dollar and fifty cents (\$1.50) per license and five dollars (\$5.00) per bond.

In making application each person shall be required to answer the attached questionnaire.


Any person who violates the above ordinance shall be fined not less than fifty dollars (\$50.00) nor more than five hundred dollars (\$500.00).
