They did discuss the drainage reconstruction currently taking place on Red Brook Rd. It does not have anything to do with SVA, but Sue advised that they will be repaving the road once the drainage project is completed.

Sue received interest from three individuals to serve on a pond subcommittee. At this time Sue is monitoring the activity of the Conservation Committee and until the town hears about the restoration grant request, no additional subcommittee activity is needed at this time.
