\_\_\_ Site & Sewage Plan – Drawn by a registered engineer, must show location of house, garage, and deck if any and include location and engineering of septic system and well. The location of septic systems and wells on adjoining properties must also be shown.

\_\_\_ A Town of Mashpee Building Permit

\_\_\_ A Town of Mashpee Board of Health Letter. Also a Department of Environmental Protection letter (if applicable).

\_\_\_ (if required by Mashpee Board of Health) An SVA Grant of title 5 Nitrogen Loading Restriction & Easement of Facility Land document, an SVA Grant of Title 5 Nitrogen Loading Restriction & Easement on Credit Land document.

\_\_\_ Certificate of Insurance including \$ limits for liability, workmen's comp, vehicle and sub contractor liability.

\_\_\_ Landscape Plan - Plan must be drawn to scale and include location of all new plantings, lawn grasses mulched and/or wood chips. Layout, dimensions and materials of driveway and walkways must also be included and underground irrigation systems must also be drawn.
