Debbie Anderson

Debbie Anderson has been working as an advocate for people with disabilities since she graduated from the Partners in Policymaking program in 2001. She has served as a Region 6 Representative on the DBHDD GAPD Advisory Board since 2017. Debbie has gained an incredible amount of knowledge from all of these experiences, but mostly she has learned from her son, Max. Max and his experiences with autism have been

her best teacher for understanding how to help individuals and families create meaningful lives for their loved ones with disabilities. Debbie is grateful to have used the Participant Direct model for Max's Medicaid COMP Waiver since 2015. Debbie lives in Columbus, Georgia, and currently serves as part-time Director of Music at St. Thomas Episcopal Church and at Temple Israel. She recently retired as the Musical Director of the Springer Opera House—the State Theatre of Georgia—and as adjunct faculty at the Schwob School of Music at Columbus State University.



Meghan Burke-Abowd

Meghan Burke-Abowd is a retired mathematics professor who, with her husband Gregory, has three children in their 20s: a daughter and two sons who both have autism. Her older son has a NOW waiver that she has been self-directing for many years. Recently, the family purchased a condominium in Decatur with a plan to build a neurodiverse residential community that could eventually support an inclusion concierge.



Pam Blanton

Pam Blanton's career has spanned 30 years in special needs housing. As a housing coordinator in Seattle, Washington, she assisted 450 people with IDD with their move into housing over 5 years. She has an in-depth working knowledge of how to help people navigate SSI, SSDI, State Residential Support, Medicaid-funded personal care services, supported employment income, and Section 8 housing subsidies.

She has been called a tenacious problem-solver, and that is what drove her to start Partners4Housing in 2010. She knew there had to be a better way for families of individuals with IDD to find roommates and set up shared housing solutions. Her goal, and her company's mission, is to empower families to create housing solutions that meet the unique needs of their Loved Ones with IDD and create a real solution for the future. To date, Partners4Housing has helped families create 66 shared living homes serving 134 people with disabilities, and they have helped over 2,000 families navigate multi-siloed social service systems to access the benefits to support a person-centered housing solution. pam@partners4housing.com





Danny Bryant

Danny Bryant graduated from Tucker High School in 2012. He then participated in a four-year Advanced Leadership and Career Development Program (ALCD) at Kennesaw State University, for which he received a certificate of completion. Danny has been independently employed at Publix for the last four years and hopes to transfer to a new department with the assistance of Supported Employment Services.

COMP Waiver-funded services have enabled Danny to live independently with one of his peers in his apartment in the Dunwoody area. He is continually progressing in socialization and life management skills. Danny is very serious about his health and wellness and represents Adult Disability Medical Healthcare (ADMH) as an ambassador charged with raising funding and awareness for the program. He is a strong advocate for adults living with developmental disabilities and is a board member of the Down Syndrome Association of Atlanta. He also participates annually in the Georgia Council on Developmental Disabilities (GCDD) Advocacy Days campaign.



Bradley Carlisle

Bradley Carlisle is 34 years old and was born with Down syndrome and congenital heart defects. Bradley attended most of his school years in DeKalb County but graduated from Alcovy High School in Newton County. After graduation, Bradley applied for and received the NOW/COMP Waiver for both services and residential living. Bradley chose to move into a host home at the age of 23, where he lived for 10 years.

In August 2022, Bradley decided he wanted to live more independently and work. Bradley also decided that he wanted to live in the Dunwoody, Georgia, community where he had more opportunities to meet his needs and interests. Bradley transitioned his NOW/COMP waiver into Participant Direct to fulfill these goals. In October 2023, Bradley moved into his own apartment with his roommate, Danny Bryant, and secured a job in his community at Chupitos (a Mexican restaurant).

Bradley served three years on the Down Syndrome Association of Atlanta Board and in 2023 was voted to serve three years on the National Down Syndrome Congress Board. Bradley is very involved in a theater program called Habima at the Jewish Community and has performed in six plays.

Bradley is a strong advocate for his community and enjoys being social and spending time with friends.

She has also spoken at local, statewide, and national conferences on dietary interventions for children and adults with ADHD and autism spectrum disorders. She has a 30-year-old daughter with ADHD who lives in Atlanta, and her son, Ben, a waiver participant, who lives with her in Roswell, GA.

He is also a licensed Georgia realtor with 15 years of experience in both residential and commercial sectors. Rick Thompson

Rick Thompson is Co-Founder and Executive Director of Champions Community Foundation (CCF), an Atlanta-based 501(c)(3) charity whose mission is to empower physically challenged young adults to reach their full potential for independence and belonging. CCF is expanding its mission in three ways: (1) through the development of Champions Place, a unique shared living environment for physically challenged young adults,

(2) creating opportunities to build friendships and community, and (3) leveraging what CCF has learned to impact more lives. Working with Google, CCF is now installing the same assistive technology residents enjoy at Champions Place with other physically challenged young adults in our community.

Rick and his wife Nancy, both graduates of Bucknell University, have been married for 43 years and blessed with three children; Rob, and Katie and Matthew who are both physically challenged due to a rare form of muscular dystrophy. Katie died at the age of 3 and Matthew, whom doctors predicted would die by age 10, is now 33 years old and going strong. In December of 2016, Rick and Nancy agreed it was time for Rick to leave a successful corporate career of 38 years to follow God's plans for his life—to leverage his life experiences and leadership skills to pursue this passion he was destined to follow.

During his corporate career, Rick held a number of general management positions with Eastman Kodak Company and Lexmark International, leading organizations including sales, operations, professional services, and technology.
