INTRODUCTION

The purpose of this Online Safety Policy is to provide a framework for the safe and responsible use of digital technology and the internet within Thriveology. OBJECTIVES

- To ensure compliance with relevant laws and regulations regarding online safety and data protection.

ONLINE SAFETY PRINCIPLES

- 1. Safe and Responsible Use: All users must understand and adhere to safe practices when using the internet and digital devices to avoid risks such as cyberbullying, online predators, and exposure to inappropriate content.
- 2. Digital Citizenship: Students and staff should be educated about the importance of digital citizenship, including respect for others online, understanding privacy settings, and recognising the impact of their online actions.
- 3. Privacy and Data Protection: All users must respect the privacy of others and comply with data protection regulations. Personal information should not be shared without consent, and users should be aware of the implications of sharing personal data online.
- 4. Monitoring and Reporting: Thriveology reserves the right to monitor internet usage and digital activities on organisational devices and networks. Users are encouraged to
