He conducts powerful legal seminars every year designed to assist churches and other non-profit ministries understand the ins and outs of the most important and pressing legal issues facing them today, including the LGBTQ agenda, child abuse prevention, counseling liability, and many others. As a trial attorney, he fights to protect the sanctity of life from conception to natural death and the religious freedom rights of those who believe in traditional, God-ordained marriage. Meeting regularly with influential members of Congress, he also introduces legislation designed not just to stem the tide of anti-Christian discrimination, but to promote and protect the values upon which our nation was founded. 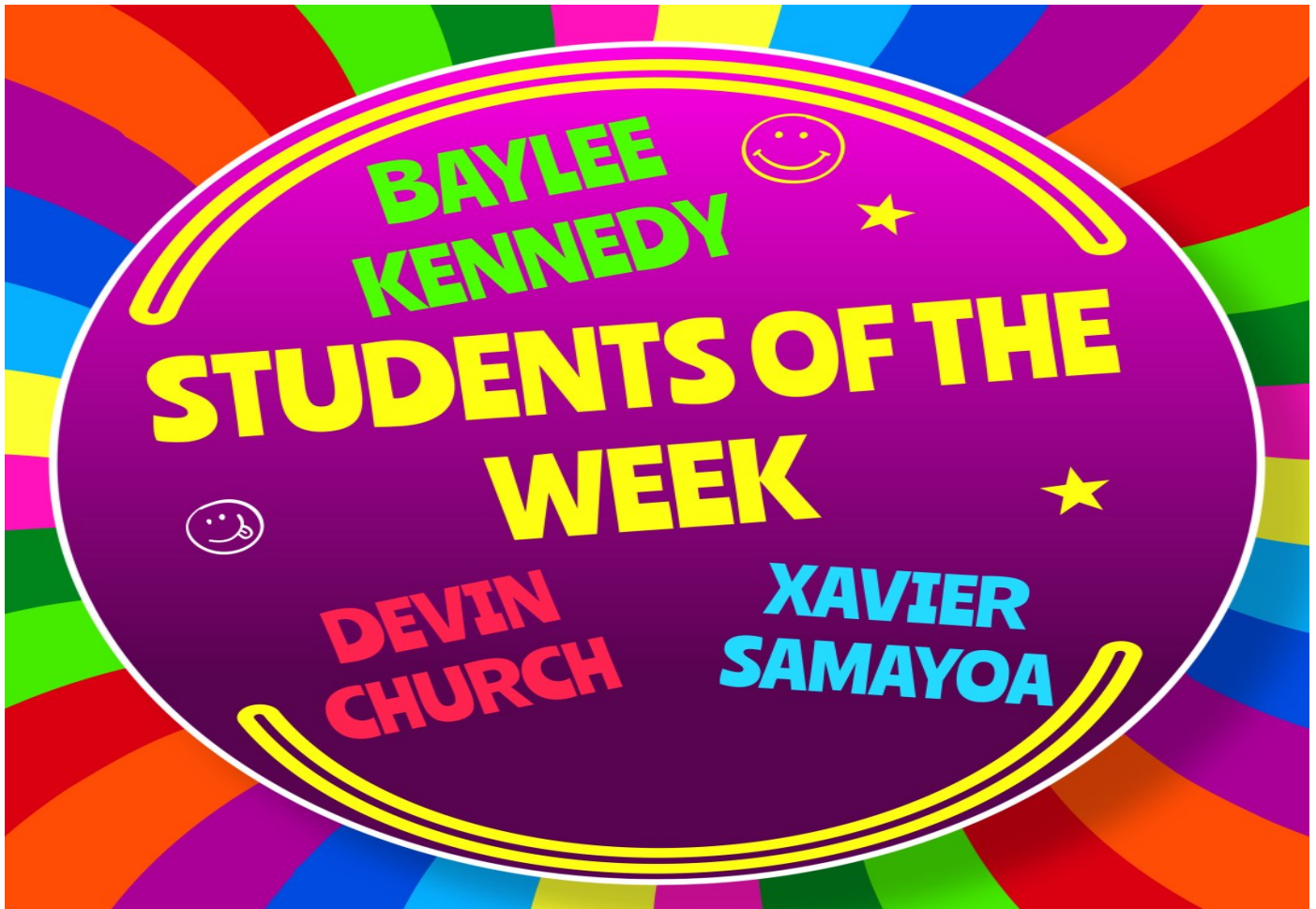

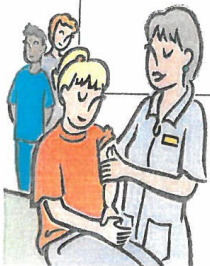

- 5 doses of DTP/DTaP
- 3 doses Polio (if 3rd dose given after 4th birthday)
 - *4 Polio (if 3rd dose given before 4th birthday)
 - *5 Polio (if 4th dose given before 4th birthday)
- 2 doses MMR, 3 doses Hepatitis B
- 2 doses Varicella
or verification of Chicken
pox
