We realize we must meet the requirement of support for Sacred Heart Church in Covina in order to receive In Parish Tuition rate for the 2022-23 school year as well as subsequent school years.

Tuition – To qualify for "in parish rate", all of the following criteria apply:

- At least one of the parents is a practicing Catholic.
- The family attends Sunday Mass regularly.
- Parents are registered and active members in Sacred Heart parish life for at least one year prior to registration.
- An offering is made to Sacred Heart Church (minimum \$300.00 per year). Accounts are evaluated each January before registration (Families are asked to provide the statement received from the parish that indicates their contributions for the previous year.)

2 Children	\$10,000.00 (\$1000.00 - 10 pmts./\$910.00 - 11 pmts.)
3 Children	\$15,000.00 (\$1,500.00 - 10 pmts./\$1,364.00 - 11 pmts.)
4 Children	\$18,850.00 (\$1,885.00 - 10 pmts./\$1,682.00 - 11 pmts.)

-the 4th child rate includes a discount for the 4th child tuition (discount is taken on regular one child tuition not on TK/K)

Tuition is paid in one of the following ways:

- ▼ IN FULL: One payment in full due by August 22th. A \$100.00 Discount is available if a full year's tuition is paid in full. (this is the only opt out of FACTS)
- ▼ TWO PAYMENTS: One payment is due by August 10th and the other due by January or February 10th
- ▼ MONTHLY: Ten payments, <u>September through June</u>, Eleven payments, <u>August through June</u>, or Twice- a- Month payments, made through the FACTS Tuition Management Program by automatic debit. Each family will select a date for the payment to be debited each month for the year.
- ▶ All tuition accounts paid by check or cash are due on the 10th of the month and are late after that date. A fee will be added to your account for late payment or insufficient funds.
- ♥ Payment of all applicable registration fees. These fees are Non-Refundable.
- ▼ Monthly payments must be met on time and must be up-to date in order to receive reregistration materials.

In Parish Tuition families also have a fundraising and service hour requirement to fulfill. Please see the reverse side for information.

FUNDRAISING REQUIREMENTS FOR ALL IN PARISH FAMILIES 2022-23

• Mandatory contribution as follows:

1 child	\$1,010.00
2 children	\$1,360.00
3 children	\$1,710.00
4 children	\$2,060.00

These contributions are to be made in the following manner:

- Mandatory Sale of 23 Football Mania Tickets per family (extra tickets, if available distributed first come, first served) AND 20 HoopsMania Tickets per family.
 - Tickets sold at \$20.00 each for a total of \$460.00 for FootballMania
 - Tickets sold at \$10.00 each for HoopsMania for a total of \$200.00 for HoopsMania
 - Total \$460.00 is due by August 22, 2022. (A \$25.00 late fee applies after 8/22/22)
 - Total \$200.00 is due by February 10, 2023. (A \$25.00 late fee applies after 2/10/23)
- Mandatory Festival "Start up" payment of \$100.00 per family is due at Registration
- Based on the above requirements, the remainder of the requirement is as follows:
 - 1 child <u>\$250.00 remaining</u>
 2 children <u>\$600.00 remaining</u>
 - 3 children **\$950.00 remaining**
 - 4 children **\$1,300.00 remaining**

These amounts can be paid off through fundraising (PTO sponsored activities designated as fundraising credit opportunities), in monthly payments added to FACTS account or in one lump sum, however, in order to re-register and/or participate in graduation activities, each family must have a fundraising balance of NO MORE than \$200.00 by February 28, 2023.

- ***Families may wish to utilize <u>scrip</u> as a means of earning credit toward their fundraising requirements.
 - Scrip may be purchased through the Scrip Program. Credit given will be based on the listed percentage for a given merchant.

Other fundraisers may or may not be offered during the year

OVERPAYMENT OF FUNDRAISING WILL NOT BE REFUNDED NOR CREDITED TOWARD TUITION OR DAYCARE. NO CREDIT WILL BE APPLIED TO PREVIOUS OR FUTURE YEARS. THE EXCEPTION WILL BE THE "HAVE A HEART" PROGRAM.

• Families are advised to check with their tax accountants to determine if payments qualify as taxdeductible.

Total Fundraising Requirement for each family must be met in full by May 31, 2023.

SERVICE HOUR REQUIREMENTS FOR ALL FAMILIES 2022-2023

- Time/Talent
 - 2-Parent Families: 40 service hours to Sacred Heart School during the school year to be completed by the end of May. 13 of the 40 hours must be for the Festival. (3 of these hours pre/post festival to be assigned by festival committee.)
 - 1-Parent Families: 30 service hours to Sacred Heart School during the school year to be completed by the end of May. 13 of the 30 hours must be for the Festival. (3 of these hours pre/post festival to be assigned by festival committee.)
- Monetary Payment
 - <u>13 hours of service to Sacred Heart School which must be for the Festival</u>. The remainder hours may be paid for at \$25.00 per hour.
- ***Failure to do Festival Hours will result in a fine of \$50.00 per hour. This must be payable before March 1, 2023.
