- 4. By Law review

Chair Jacob Odermann addressed the proposed bylaw changes to be drafted and voted on in the next meeting. Changes are summarized below:

- 4.1 Article 4 must be paid and registered seven days prior to the nominating convention
- 4.2 Article 5- Section 4 & 5 Clarifies who can be on the executive committee of District 39
- 4.3 Article 9 Section 1- Endorsement of candidates and election of delegates to state party convention. This adds additional detail how and who can nominate for the two legislative seats and the state senate; individual must have 1 of the following criteria:
 - a. Member of the North Dakota state republican party and paid dues in calendar year prior to the nominating convention while also residing in district 39
 - b. Member of District 39 Executive committee in calendar year prior to the nomination
 - c. Member of District 39 Republican Committee and paid their due prior to the nominating convention.
- 4.4 Article 9 Section 1- If you intend to run for house or senate that you notify the chair 10 days prior to nominating convention.
- 4.5 Motion by Jim Odermann to adopt the bylaws as changed. Motion seconded by Jason Dodge. Discussion called.
- 4.6 Luke Simons moved to Amend the Main motion to strike the seven-day pre-registration requirement in Article 4. Amendment to the main motion seconded by Jason Dodge. Discussion to the amendment called. Chairman Odermann called for the vote. The Amendment to the main motion to remove the seven-day pre-registration requirement in Article 4. The Amendment to the Main motion passed.

- 4.7 Motion by Andrew Kordonowy to strike out the 10 day requirement to notify the chair of nominees and be able to nominate from the floor. Discussion. Point of Order from the floor: Agenda states that this meeting will review the bylaws and the approval of the bylaws will take place on February 28, 2022. Discussion. Point of order from the floor: There is a motion on the floor that must be handled. The final ruling is that the agenda calls for a by-law review. All motions subsequent to the by law review must be rescinded.
- 4.8 Andrew Kordonowy moved to rescind his motion to strike out the 10-day requirement to notify the chair of nominees and to be able to nominate from the floor. Motion to rescind passes.
- 4.9 Luke Simons moved to rescind the amended motion to the seven-day pre-registration requirement in Article 4. Motion to rescind the amended motion seconded by Jason Dodge. Motion to rescind passes. Note: The Amended Main Motion to adopt the By Law changes and strike the seven-day pre-registration requirement in Article 4 was not voted on.
- 4.10 James Odermann moved to rescind the main motion to adopt the By Law Changes. Motion to rescind the main motion seconded by Jason Dodge. Motion to rescind passes.
