WHITE - BELLIED SEA EAGLES Max Tischler

THERE IS ONE THING AT ROSEDALE THAT **NEVER CEASES TO DRAW A GASP OF EXCITEMENT FROM MY LITTLE NEPHEW** JONATHON. HE'LL BE ABSORBED IN A SANDCASTLE OR CATCHING WAVES ON HIS BOOGIE BOARD YET WHENEVER A WHITE-BELLIED SEA EAGLE FLIES OVER HE'LL STOP WHAT HE'S DOING LOOK UP, POINT AND ALMOST TIP OVER **BACKWARDS IN AN ATTEMPT TO WATCH** THE MAJESTIC BIRD FLY OVERHEAD. IT'S SOMETHING I REMEMBER DOING WHEN I WAS HIS AGE AND MUST CONFESS IT STILL THRILLS ME. AS SEA EAGLES CAN LIVE TO THE AGE OF 30, I OFTEN WONDER IF THE BIRDS THAT FREQUENT ROSEDALE TODAY ARE THE SAME ONES, OR OFFSPRING FROM PARENTS BACK THEN.

The white-bellied sea eagle (Haliaeetus leucogastor) is the second largest bird of prey (raptor) in Australia. Their wingspan can reach up to 2.2 m and an adult female often weighs just over 4 kg. This doesn't sound like much (about the weight of a small dog), but because lightness is advantageous to flying, all birds have hollow bones (even emus). Interestingly, white-bellied sea eagles like many other raptors display what is called sexual size dimorphism, or more simply: females and males are quite different in size. The females are the larger of the two, and the main reason for this is that it allows paired birds (which are monogamous) to hunt for a broader range of food items than they could by themselves. This ensures strong pair bonds, and can account for seasonal fluctuations in food availability. Consequently, white-bellied sea eagles can feed on a range of prey items including fish, smaller birds, mammals, reptiles and sometimes carrion. Fish is the favoured food, and birds will often snatch prey from the surface of the water before carrying it to a prominent roost site to feed. There is an old dead tree on Jimmie's Island that seems to be a favoured dining spot.

Sea eagles mate for life and usually breed between June and January, returning to the same nest year after year. Nests are typically large constructions made from sticks and green foliage in tall prominent trees. I am yet to discover where the Rosedale pair nest but imagine its somewhere in the wooded areas of the old farm or thereabouts. Two eggs are laid, and the female is responsible for almost all of the six week incubation period, whilst the male undertakes regular hunting forays to feed them both. Usually only one chick survives the 90 or so days to fledge, after which it will spend another month with the parents before being sent on its way. It will take five years for a youngster to reach maturity, during which time the plumage undergoes a

gradual transition in colouration from messy brown to the striking skewbald grey and white of adult birds.

White-bellied sea eagles are found in a range of coastal habitats right around Australia, as well as along many of the river systems and wetlands of far inland. In fact the proliferation of introduced carp in the Murray-Darling Basin has most likely benefitted sea eagles. No doubt the birds we see flying overhead wander up and down our small stretch of coast exploring and foraging in the estuaries (like the Tomago), inlets and bays (like Rosedale). Unfortunately the increased pressure of human activity in these areas also threats the long-term survival of the sea-eagles. So ensuring sensible conservation of our marine resources and planning in associated habitats is important for the future of this toporder predator.

On a few occasions I have been treated to an extraordinary spectacle by the pair of sea eagles at Rosedale. With both birds high in the sky, they locked talons (feet) and went into a freefall, tumbling to within 30 m of the water before releasing each other. They then flew skywards only to repeat this interesting mating ritual. This is a behaviour (like so many) displayed by raptors that is well known but poorly understood. Birdlife Australia have contributed a lot to our understanding of sea-eagles over the last few years having installed remote cameras near a nest site in Homebush Bay, Sydney. You can go online and watch the pair in real time. I am guilty of having spent many hours enthralled by this 'reality tv' program. ROSEDALE'S DIAMOND PYTHONS

Take a look on the right at this handsome diamond python (*Morelia spilota spilota*) snapped by Damian Egan who walked into it in a tree outside Noel Egan's Rosedale house. There is another python in residence down near the boatsheds.

Pythons are not venomous so please leave them be! You can distinguish this snake by its distinctive black background with cream or yellow spots and blotches. It will grow to two or even three metres.

Diamond pythons feed on small birds and mammals – but they often take up residence in the roof space of houses where they eliminate rodents. Once their food supply is exhausted they'll move on.

Meanwhile red bellied black snakes (*Pseudechis porphyriacus*) are venomous, though there's an antivenom available. We know of at least one which lives in the rock embankment between 45 and my house at 47 Yowani Road – and another in a tree stump at Keith and Mary Boardman's house at number 33.

Fortunately bites are rare – if provoked it will rear into striking stance and hiss, but it will try and escape as soon as it can. Keep an eye out as this snake feeds by day.

SUE FALK

The Rosedale Association regrets the death of Sue Falk in Sydney on November 20 2011 after a short illness.

Sue had from childhood a long association with Rosedale. Her parents, John and Enid Falk in the early 1960s arranged with Miller, the developer and builder of many houses in Rosedale, for a house at the end of Yowani Road in North Rosedale. It was a treasure in her life. Sue was a frequent visitor and cherished the time, albeit not as much as she would have liked, to while away her leisure hours. Rosedale provided a great break from her busy musical and teaching life in Sydney.

Sue was a staunch supporter of the Rosedale Association and was prepared to step in and take on leadership roles in the Association whenever there was a need. She would fill the vacuum. Her roles included that of acting Chair, Secretary, Newsletter Editor and she will always be remembered for her initiative to secure legal incorporation of the Rosedale Association.

She was intelligent, had a fine mind and was always willing and able to marshal others and push things along when required. She was a masterful chair of Association meetings. She will long be remembered

with fondness for her contribution to the Association and its ideals.

Born in Sydney in 1945, Sue was a graduate of the Australian National University in modern languages. She also studied in Paris at the Ecole Normale de Musique, where she received the Licence de Concert. In 1996, Sue graduated in law from the University of New South Wales.

Sue was well-known as a performer of baroque music throughout Europe in the 1970s. She specialised in a study of early and contemporary French music and received a number of French awards for her contributions. Sue also was a gifted soprano. In the 1970s, she gave recitals and appeared in opera houses through Europe in a number of operatic roles.

On her return to Sydney in 1980, Sue established a private teaching studio as well as teaching as a part-time lecturer at the University of Sydney and the University of New South Wales. She appeared for the ABC, Musica Viva, Sydney Philharmonia Society, Sydney Baroque and the Australia Opera among others.

ABALONE POACHERS

Following David Boardman's report on abalone trafficking last March, Yvonne Brennan and Elise Stutchbury were shocked to discover up to 75 freshly shucked abalone shells collected between the marine platform and Nun's beach.

This area is part of the Sanctuary Zone from Jimmie's Island around Nun's beach to Guerilla Bay. It's a no take zone - no fishing or collecting of any species of plant or animal, dead or alive.

WHAT CAN WE DO?



COUNCIL UPDATE David Boardman

Those of you thinking of renovating or building will need to know that there are new design rules in the wings.

A Draft Local Environment Plan (LEP) 2011 was adopted by Eurobodalla Shire Council on 18 October 2011 and has been sent to the NSW Government for processing and gazettal. Rosedale is zoned E4 - Environmental Living compared with 2ec- Environmental Constraints under Urban LEP 1999.

Both E4 and 2ec zones allow for the erection of dwelling houses with consent. Other activities associated with residential development (including home business, home-based childcare, keeping of animals, erection of sheds, garages and outbuildings) are permitted in both zones either as exempt development, complying development, development that needs consent or as activities that are ancillary to a dwelling house.

CHANGES

There are several changes in this draft plan compared with the 1999 Urban LEP. Dual occupancy and secondary dwellings will now be permitted with consent, rather than prohibited. Bed and breakfast and eco-tourism facilities will be now be permitted with consent, rather than given blanket approval. Some agricultural activities will now be permitted, including bee keeping, viticulture and farm buildings, compared with a previous prohibition except for personal use (for example, vegetable gardens).

Under the 1999 Urban LEP the controls for floor/space ratio and height were in the Residential Design Code. The code stipulated a maximum floor /space ratio (FSR) of 0.35:1 and a maximum building height of 8.5 metres from natural ground level with a two storey limit.

In contrast, the Draft LEP 2011 contains maps outlining the maximum building heights for particular areas. The land within and surrounding Rosedale falls within category 1 which has a maximum building height of 8.5 metres. The Eurobodalla Shire Council has not adopted maximum FSRs in the Draft LEP; instead the building envelope will be planned through other controls in the Residential Zones Development Control Plan such as minimum setbacks, landscaped area and the maintenance of neighbouring views and privacy.
