Review of prior Board Meeting Minutes:

- KP stated that power washing of the breezeways will be taking place soon – MC followed up via email
- Homeowner stated that the siding needs to be repaired or replaced at 21880 Railway 303 – MC sent this
- KP stated that trash only gets picked up 6:30 am Tuesday and Friday so if you place it out before that time, you will get a violation
- There is a tree that needs to be trimmed behind 21855 Railway
- Homeowner stated that the outlets on her balcony don't work since they were redone
- There are 2 mint plants that are on Elkins and Caboose
