

#### **Training/Outreach**

This Quarter began my "Let's Talk" landowner workshop series. I designed this series to have a landowner workshop every month. A majority of these workshops will include a landowner talking about their personal experience with the topic of the workshop. The landowner who is presenting talks about what they have learned while completing a practice, their failures and triumphs, and the results they have seen once the practice is completed. The other presenters will be conservation professionals such as NRCS and MDC employees.

My first workshop in this series focused on Brush Management. I hosted this workshop on Mr. Hartman's property. Mr. Hartman and his father were my landowner presenters for this workshop. They were able to talk about what worked for them and what did not. They also discussed the equipment they used, what species they were targeting, and took the attendees out on a field tour to show what the property looked like before and after their efforts. This workshop was hosted in the beginning of November. Along with the landowner and his father, FBB, Jonathan Dew, with Quail Forever and Area One Forester, Tyler Rodes, with NWTF presented as well.

The next "Let's Talk:" workshop focused on invasives. This workshop was hosted in the beginning of December at the Liberty NRCS Field Office. For this workshop, I had one of my landowners, Mr. McCoy, come in and give a talk about his efforts for invasive species control on his property in Ray County, that he has been working on for over 15 years. He was focused on control of Sericea Lespedeza and Cedars. I also had Soil Conservationist, Eric Cameron out of Liberty talk about terrestrial invasive species and MDC PLC, Cassandra Messer, talk about pond invasive species.

Both of these workshops have yielded great landowner discussions amongst one another as well as great questions to the instructors. The next "Let's Talk" that I have planned will be at the end of January and will focus on the different cost share avenues a landowner can utilize including but not limited to, NRCS EQIP/CSP, MDC LCAP, and U.S. Fish and Wildlife Partners for fish and wildlife program.

Coming up in 2024, we have some things to look forward to. EQIP and RCPP assessments will be completed by February ninth. EQIP round one preapprovals will begin on February 26th. RCPP preapprovals will also begin on February 26th. Continuous CRP signups began on January 12th. I will also begin compiling lists and maps for expiring CRP checks that will expire in September of 2025. CRP implementation checks will also be compiled for me to begin this year for new CRP seedings that are 2-3 years old.

#### **Position Update**

The second quarter of FY'24 was action packed starting off with the Missouri team meeting. We gathered in Eureka, MO to focus on team building as well as discuss important topics such as plans and goals for the year.

Due to weather and hunting season in late November and December, demand for site visits decreased. This has allowed me to focus on putting my Prescribed Burn Planner Certification to use knocking out my first burn plan with many more on the way.

A large part of my workload this quarter was continued participation in the research project through Working Lands for Wildlife and the University of Georgia. The use of Acoustic Recording Devices and accompanying point county surveys helped identify which conservation practices are effective in increasing Northern Bobwhite populations.

### Working Lands for Wildlife ARU Study

This fall, I was able to continue my work on the WLFW ARU study looking at conservation practices and their affects on Northern Bobwhite populations and other focal bird species. The fall portion of the study also required the deployment of Acoustic Recording Units to listen for coveys inside the designated area. In person covey counts were conducted in conjunction with the ARU's to confirm the accuracy of the devices.

During the fall, there can be a variety of different weather conditions from day to day. It was really interesting to see how the quail migrated throughout the property depending on weather. In early October, I recorded quail throughout the properties. It seemed they had no real preference for a certain region. However, during mid to late November, quail were recorded concentrated around shrub cover and woody draws. This demonstrates the importance of thermal cover to protect them from the elements as well as from predators.

#### **MDC Prescribed Fire Workshop**

One of the most enjoyable aspects of my position is interacting with the public to discuss important topics in the world of conservation. I had that exact opportunity this winter to assist MDC's Rich Crowe and Shane Strommer with a Prescribed Fire Workshop. Prescribed fire is one of the best tools for wildlife management we have available. This method is cost-effective and can accomplish many goals the landowner may have dependent on the timing of the burn.

The information presented during the class was aimed towards safety measures and protocols that should be implemented prior to and during the burn. Topics such as types of burn lines, fire weather, and watch out situations were highlighted throughout the class.

This workshop is a requirement for all landowners who wish to implement prescribed fire on their properties currently enrolled in cost-share programs such as CRP. Landowners who pass the online portion and attend one of many workshops throughout the state will receive their certification to conduct burns on the landscape. 

#### Working Lands for Wildlife (WLFW)

Being a Working Lands for Wildlife Biologist, part of my yearly duties are to do quail surveys on landowners properties to see how well wildlife plantings and habitat restoration are helping the quail populations. This fall I did not have my own set of survey areas due to not having data from the spring roosting counts, but I was still able to join fellow Farm Bill Biologist, Will Robinson, on setting up ARUs (Automatic Recording Units). ARUs are used to listen for quail whistles starting 45 minutes before sunrise to 15 minutes after sunrise, when quail calling is most active. Will was able to show me how to properly set up the ARUs for re-

cording at the proper times. Along with the ARUs, the research team out of Georgia have us go to certain locations to sit next to the ARU and do our own surveys, to ensure the ARU is correctly working and picking up what we also heard. It is always nice to do some population surveys to provide confidence in how well programs are working.

#### **Benton Elementary School Invasive Poster Judging**

Jake Swafford, Coordinating Wildlife Biologist, and I had the opportunity to do some outreach at an elementary school in Columbia. Benton Elementary is a STEM (Science, Technology, Engineering, and Math) school located near downtown Columbia where kids learn STEM topics on top of their normal curriculum. When Jake and I visited, they were researching invasive plants in Missouri, specifically Autumn Olive and Callery Pear. The 5th graders of Ms. Carrow's class were assigned a plant and had to make a poster outlining the dangers of the invasives on our local landscape and give some advice on how to eradicate them. The students did an amazing job creating the posters and even mentioned alternative native species to plant instead of the non-native invasives. At the end of our time there, we gave out native wildlife seed packets. Many of the students were beyond excited to plant them in their yards.



#### **New Seed Mix**

An interesting project I have been working on has been the creation of a high diversity grazing mix for Missouri. During a webinar hosted by the WLFW east region, I learned that Arkansas has a designated high diversity grazing mix that includes high protein and palatable plants for cattle. This has led to the discussion of creating one for Missouri, giving landowners an opportunity to create good grazing land that will also benefit wildlife. The mix includes many types of forbs/legumes and three grasses. It is not done yet, but I am excited to keep working on the mix and have it available to Missouri landowners when the time comes

#### **Position Update**

At my 1.5 year mark on the team, I have continued to familiarize myself with the ACEP-WRE program structure. This quarter, I have aided in all parts of the easement application and design process including, monitoring, surveying, planning repairs, ranking, and plan writing. Fortunately, there is always more to learn and achieving proficiency in some portions of the program opens the door to the opportunity to develop additional competencies and deepen relationships with landowners. Additionally, the WETs 1 team has a big year upcoming with new easements being enrolled, planned, and surveyed, and I am looking forward to helping with all portions of the process. I have always enjoyed educating the public and I am working on developing a couple recurring events that will be previewed in March and April of 2024.

#### **Wetland Landowner Workshop**

On what had to be the first truly cold, rainy day in October, the WETs West staff hosted a landowner wetland workshop. Aside from a bit of chilly weather, the day went off without a hitch. The Carroll county easement where the workshop was held was being flooded in anticipation of arriving teal and said teal were in residence. Landowners and local NRCS staff cycled through information stations while flocks of blue-winged teal wheeled and dove with a peregrine falcon pursuing them across the sky.

The workshop sought to offer landowners a view of an easement managed not just to attract birds but to hold them. Former MDC Wetland Services Biologist, Mike McClure, is a part-owner on this site and uses it to highlight the benefits that can come from a holistic management philosophy. In particular, Mike promotes providing ducks shelter from elements, secluded areas free from hunting pressure, and maintaining mixed vegetation types.

This workshop was a great opportunity for the WETs team to highlight good management practices, connect with easement owners, and offer local NRCS staff insight into the ACEP-WRE program. Keep a lookout for upcoming workshops in to be held in northwest and southwest Missouri in the coming year.



### New Equipment Available to **Local Landowners**

In September of 2022 local Farm Bill Biologist III, Wesley Hanks, submitted a grant proposal, that was approved in October 2022 to have a pendulum seeder unit purchased and assembled. A pendulum seeder is a broadcast seeder well suited for seeding diverse native seed mixes typically established to benefit pollinators and create brood rearing habitat for quail and turkey. Assembly of the unit was completed in October of 2023 and is now available for landowners in Franklin and surrounding counties. The seeder isn't just for seeding natives, it can be used to establish any type of annual or green browse food plot along with spreading fertilizer. The seeder will be housed at Shaw Nature Reserve (SNR) in Gray Summit and the crew at SNR has agreed to take care of routine maintenance. Anyone

interested in using the seeder on their property can contact Wesley Hanks at (573) 301-9672 or whanks@quailforever.org. There is a \$30.00 per day rental fee that will go to the MO River Valley Chapter of QF to cover insurance and repairs. While most funds to pay for this seeder came from NWTF, the Missouri Dept. of Conservation, SNR, and the MO River Chapter also contributed dollars to purchase this equipment.





#### **New Beginnings**

Hopefully, this will be my shortest quarterly report due to the fact that my employment with PFQF didn't begin until Thanksgiving week of 2023. I am incredibly excited to begin this new venture with such a

prominent and respected conservation organization. So I figured the best way to kick off my first report is to give a little background about myself and what you can expect from me in the future.

During my senior year at Northwest Missouri State University, (which was from fall 2019 to spring 2020) I was employed as a biology technician through the university and worked at Loess Bluffs National Wildlife Refuge. It was my time working at the refuge that my love of wetland ecology began. The experience and knowledge I gained from the staff at Loess Bluffs was crucial to developing my foundation as a wildlife professional with a keen interest in the world of wetlands. I also volunteered much of my time outside of work to assist biologists from MDC and Missouri DNR with various projects including fish surveys and water quality monitoring.

Prior to my employment here at PFQF as a Wetland Specialist, I was employed at an environmental consulting firm as a Wildlife Biologist where I further developed my skills working with private landowners throughout Kansas and Nebraska who wished to restore the streams that ran through their ranches. Our main focus was implementing structures called beaver dam analogs (BDAs) which have shown promise out west, but this was one of the first times this practice was being implemented in the Great Plains region.

I'm currently working with my team to learn all aspects of the Wetland Reserve Easement (WRE) program in order to best assist the landowners of southwest Missouri. I have been assisting with writing compatible use agreements (CUAs) and have been conducting site visits with the team to provide technical assistance to landowners currently enrolled and wishing to enroll in the WRE. On top of that, I have been attending workshops to further my knowledge of NRCS programs and tools to further enhance my capabilities as a Wetland Specialist.

Training/Meeting Type	Outcome
Conservation Desktop Workshop	This was my introduction to a software program that I will be utilizing daily to write Compatible Use Agreements for landowners enrolled in the WRP. I also met many of my colleagues in PFQF as well as from partner organizations such as MDC and NRCS as well as toured the state office.
CRP Menu Workshop	This workshop was organized and presented by staff and students from Mississippi State University. They are currently developing an online tool that would assist landowners as well as NRCS staff and partners with understanding eligibility requirements for enrollment in CRP as well as providing estimates based on acreage, land use and other factors. This tool could eventually be expanded to other programs such as the WRP.


#### **Looking Forward**



#### **Quarterly Overview**

We started this quarter off with a bang by gathering together for our annual team meeting. We met as a team both to recharge for the upcoming year and celebrate last year.. Throughout the meeting, we were able to listen to guest speakers, tour a landowner's properties, present awards to our hard working staff, and relax with our teammates. I was privileged to attend and participate in several workshops, training events and partner meetings throughout the quarter as well. I also had the chance to go out in the field which allowed me many opportunities to provide positive feedback and recommendations for habitat. With the coming of the dormant season, I was able to find some time to sit down and visit with landowners about burn plans and draft several plans so they could complete management for various programs. Even with as much planning as we do ahead of time, I am always surprised by the unexpected opportunities that show up as the quarter moves on.

#### Haying and Grazing CRP

The FSA office in Trenton reached out to me and asked if I would help them conduct having a grazing inspections on CRP from last summer. Because of the wide ranging drought across Missouri, all my counties were able to open up landowner's CRP for haying and grazing, if the landowner chose to. Several landowners requested to hay their CRP and part of the process includes checking fields to make sure it was hayed appropriately and the hay has been removed from the field in a timely manner. These checks allowed me to go out into the field during a time when I am typically in the office because most of our field work has slowed down. I was able to use these checks to view the habitat on these CRP fields and offer suggestions to help make the habitat better for wildlife. With the cover cut, it provided a good look at the fields and made it easier to identify if there were invasive species that needed treated or management that needed conducted.

#### Horizon's II Project

In early December, I was contacted by a contractor working on a landowner that I knew inviting me to join in on a call with them and Roeslein Alternative Energy (RAE) to discuss the Horizons II project. RAE has won a grant from the USDA to complete a project of planting 40,000 acres of native grasses and forbs and 40,000 acres of cover crops for use by wildlife and use in their anerobic digesters to create natural gas. We were able to discuss the project with the landowner and look at if it is right for his property. Through this program landowners receive a rental rate payment from Roeslein and assistance in implementing the native planting. I was able to further visit with Roeslein's Conservation Coordinator and discuss the project, how it can benefit wildlife, the landowner and Roeslein as well and look at and provide advice on the mix they are using for the native plantings. This project has the capabiliuty to add 80,000 acres of quality cover crops and habitat to the North Missouri landscape and provide an incentive to landowners to plant them. I look forward to following this project helping Roeslein in this project.

#### **Connecting New Audiences**

In Early October, our Outreach Coordinator, Kim Cole, took a national level position with Pheasants Forever and Quail Forever. This allowed me the chance to manage our social media pages for a few weeks. Through this experience, I was able to create outreach material that was used by landowners, resource professionals, and general public across Missouri and many neighboring states. I was also able to help our page grow and provide more information to a variety of audiences than I do in my typical day to day activities.

#### Unique Wildlife

Within my job, I am able to help to build incredible grassland habitat. While the primary species we work for is quail and pheasants, our habitat work impacts a variety of other species particularly grassland birds. One species of grassland bird that is on the decline and interesting and unique is the Loggerhead Shrike. These song birds are birds of prey that have a distinctive feeding habit. They impale their food on thorns and or sharp objects and come back to eat it later. With the invention of barbed wire, they are able to create a convenient buffet along long stretches of fence. Like quail, these birds rely on a diverse insect population which thrives within our native wildflowers. Where native grassland habitat is restored, shrike populations are starting to increase. Their unique feeding habitats has lead to their nickname "butcher birds." Even though they are slightly smaller than a robin, using precision strikes with their beaks, they can even hunt larger prey such as mice, which also rely on grassland habitat. While it is uncommon to see shrikes, a keen eye can see when one is using an area by its displayed food. Within this quarter, I was able to photograph one shrike and identify four different locations across two counties that shrikes

are using. I was also able to inform my coworkers about shrikes and now they are on the hunt to identify areas that shrikes are using. It was thanks to their efforts I was able to find the locations where I photographed these unfortunate shrike victims. Missouri wildlife is certainly fascinating the more I learn about it.

### Grazing and Wildlife

In August, the Missouri Forage and Grassland Council along with the Missouri Department of Conservation hired Marine Osier as their Conservation Grasslands Specialists. She will be working in Northeast Missouri with landowners to promote the benefits of native plants in grazing and haying operations. In October, I was able to join Marina and Cody Colyer, NRCS Soil Conservationist for Sullivan County, in the field touring a property with a local landowner. The landowner showed us several of his crop fields where he has been experimenting with cover crops. He is a big believer in cover crop and their benefits. He has even tried having and



grazing cover crops and then recording crop yields the following year. This landowner also plans to utilize the Native Forage Initiative to establish native warm season grasses. It was a chilly morning, but an enjoyable time being able to learn from a landowner who is dedicated to conservation. I look forward to having Marina on-board and helping with work in the county. Having someone dedicated to native forages will be a valuable resource to landowners and wildlife. I know Northeast Missouri will benefit from having Marina available to discusses with farmers how they can benefit from adding native forages into their rotation and increasing their cattle's production and health.



### **Position Update**

This quarter, the team and I continued to few wrap qu а ongoing wetland restorations from this past summer. We completed construction on a massive ~300 acre pool ACEP-WRE in Pike County, another ACEP-WRE in Lincoln County, and an MDC cost-share project, restoring a ~3 acre wetland in Boone county. I also wrapped up a 90 acre forest stand improvement (FSI) contract on one of our existing easements in Knox County. With FSI becoming more of a focus on our wetlands, this landowner called at the perfect time to get the ball rolling. He was concerned about the amount of oak mortality on his land, so I decided to go drive the property with him to assess. After learning about the many years of drought and flooding in the past, I decided FSI could help relieve stress from the residual community and provide some resilience to future adverse conditions. The project was completed in October, shortly before rifle season, and the landowner was very pleased. Come rifle season, I received pictures of a smiling landowner and his friend with two mature whitetail bucks harvested from the tract. Restoring healthy wetlands across the establishing positive landscape and relationships with landowners will never get old!



#### **Position Update**

The final quarter of calendar year 2023 has been both busy and exciting. With Missouri's quail season opening November 1, landowners seemed to have quail on the mind and I was happily able to assist in providing technical assistance for producing new quail habitat around the state as well as answer questions pertaining to the life cycle of quail. I also aided landowners with their cool season grasses and helped stretch those grasses farther through the use of rotational grazing.

#### Winter Quail Habitat

The importance of proper winter habitat for quail and other ground nesting birds cannot be overstated. Native warm season grasses can be a crucial component in this habitat as they provide both shelter and food. Clumps of native grasses like those seen in the picture to the right can provide microclimates during the colder months for quail to stay warm. Temperatures above the grass can be 20°F and, in the sunlight, temperatures at the base of the grass can be as high as 80°F. The grasses also provide nutrient rich seeds that can be an invaluable food source for the birds along with other seeds from native forbs. This is another reason why allowing native warm season grasses a minimum of 35 days before the first frost date in a region is so important. Fields like the one shown on the bottom right of this page can become quail wintering hot spots and can be the missing ingredient for landowners who are struggling to hold birds on their place during the hunting season.



#### **Producer Spotlight**

Shelby County, like most of Missouri, has seen a drastic decline in the quail population since the late 1900's. There are still some quail around and many producers are doing the best they can to provide habitat for them.

One Producer that is doing an exceptional job is Wes Russell. He started working with Farm Bill Biologist, Casey Bergthold, enrolling his crop ground into CRP. He has an excellent stand of native species, shrub and tree plantings that are thriving, as well as brushy fencerows around the field. The quail love it. Recently, Wes and his son had an opportunity to expand their farm and they took it! They are adding CP43 Prairie Strips around the crop fields, and are looking to improve habitat in other places on the farm. They have also had the area trapped for the last three winters. Which, in conjunction with habitat improvements, provides a better chance of survival for the local quail population. Wes has seen an excellent response to the quail population in the area already. With this new habitat, he hopes to get closer to



what it was like in the "good ol' days". Maintaining quality habitat is hard work, but habitat works. I am excited to see how he improves the farm in the future.



#### **Position Update**

This past quarter, I've been focused on building strong relationships, whether with new staff or conservation partners. The Missouri Quail Forever team got together for our annual team meeting, where we participated in training and planned for the following year. I was also lucky to attend the Missouri Department of Conservation's Partners Roundtable, an excellent opportunity to network with partners and build support for ongoing initiatives. I'm happy with the progress the SRISP has made in its setup and am eager to hear back on the grant opportunity we were able to pursue with the support of partners. I look forward to seeing familiar faces at the QF State Habitat Meeting and onboarding our new prescribed fire coordinating biologist.

#### Missouri Expands Support for Prescribed Fire

Quail Forever is excited to be expanding its prescribed fire efforts in the state with the addition of a new Coordinating Biologist in northern Missouri. The new position will provide technical assistance for private working lands by developing and reviewing burn plans, training conservation planners, and providing other coordination services. Currently, QF supports a prescribed fire CWB in southern Missouri that has made substantial strides in training and delivery of prescribed burning practices at a statewide scale. To further complement these successes, an additional coordinator for northern Missouri is being hired to facilitate conservation planning and technical assistance shortfalls related to prescribed burning.



For lands enrolled in Farm Bill programs, prescribed fire is a historically underutilized yet highly cost-effective tool for improving quail and other upland wildlife habitat. Looming climate change effects, such as the increased occurrence and spread of wildfires driven by shifting precipitation frequencies, can be positively impacted by the intentional use of prescribed fire.

This new position will work with partners to develop prescribed burn plans, coordinate and deliver landowner and TSP training, and boost the safe and effective use of prescribed fire, further enhancing wildlife habitat on working lands. The proposed project will also work closely with qualified contractors and technical service providers (TSPs) to assist in alleviating workload bottlenecks and advancing prescribed fire efforts related to the mutual goals of PF/QF, NRCS, and other key conservation partners in Missouri.


