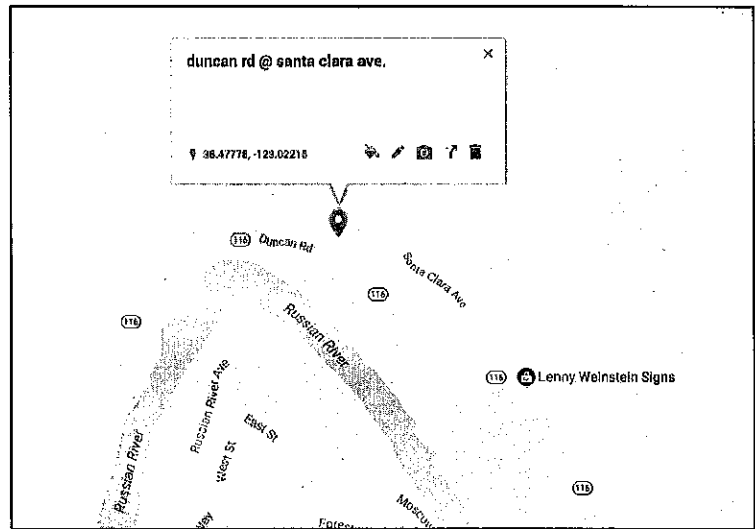
1) Cazadero Hwy: heading north 2 miles from from Hwy 116
