All money owed toward the kitten must be paid in full by 14 weeks of age. Buyers have 30 days from the initial deposit to pay in full for kittens older than 14 weeks. Any kitten not paid in full by the pickup date forfeits all money paid toward the kitten and the kitten may be resold. I UNDERSTAND AND WILL ABIDE BY THE FOLLOWING CONDITIONS OF THIS CONTRACT:

1. This kitten will be guaranteed for the first year of life on only HCM, PKDEF, PKD, and SMA. In the event that one of these should arise, the buyer must contact the breeder immediately. Documentation of proof must be provided in order to make arrangements for a reimbursement or exchange. Reimbursement will be only on the cat, no vet bills will be covered.
2. The kitten is being sold as pet only. It is to be neutered/spayed at 12 weeks of age and will only be released to go to its forever home at 14 weeks of age as long as there are no complications. The kitten will have 2 sets of vaccinations/boosters, rabies, microchip, and deworming prior to leaving the cattery. The buyer will not incur expenses if the cattery retains the kitten for observation past the pick-up date.
3. The buyer will have 72 hours to have the kitten checked by their vet. We recommend that once the pick-up date is scheduled that you call your vet and schedule this appointment. Buyer's initials _____

4. Buyer agrees to forward the full health exam and notes of the original copy of the initial vet exam to the breeder. The receipt must include the name of the hospital, vet name, address, phone, fax number, buyers name, address, date of service, feline breed, and color along with all the findings.
5. This kitten will come with a certificate of health from the cattery veterinarian – Bluffton Animal Clinic - issued within 7 days prior to pick up.
6. This kitten WILL NOT BE COVERED FOR communicable diseases after the 3 days of it leaving the cattery. It is the buyer's responsibility to keep animals and people away from the kitten until it can be seen by the buyer's vet.
7. Buyer understands that this kitten will be for pet purposes only and will not come with breeding rights. The kitten must NEVER be sold, leased, given away, put in an animal shelter, humane society, or sold to any pet store. Please contact the breeder in the event that a life situation occurs that the animal needs to be surrendered.
8. Buyer agrees that the kitten will and shall remain indoors only. This is for the health and safety of the kitten.
9. Buyer agrees to NEVER DECLAW the kitten but can clip the nails as needed. Declawing the kitten will result in void/null in this warranty.
10. Buyer MUST QUARANTINE the kitten until seen by their vet and recommended 2 weeks from all other household pets and people.
11. Buyer acknowledges the kitten will need its last booster vaccine at 16 weeks of age.
12. Buyer agrees that the seller is not responsible for any vet care or continuing vet care. Buyer's initials
13. Buyer must be patient with the kitten as it acclimates to the new environment and new owners. Buyer is not to expect the kitten to show too much affection immediately.
14. Seller DOES NOT guarantee kitten's personality traits, coat, size, or how long it will take to adjust to the new home. Buyer's initials
15. This kitten will come with a small bag of food (we feed Nulo Cat and Kitten, and Albrights Raw) to help with the transition.
