This Adoption Agreement is made by FORGOTTEN DOGS ANIMAL RESCUE, which hereinafter shall be referred to as FDAR.

I agree to adopt the pet described above. By doing so, I accept the terms of the below agreement. I understand and agree that FDAR reserves the right to reclaim the pet if any of the conditions described below are not met. FDAR may also reclaim the pet if the pet is being mistreated, abused, neglected, or made in any way unsafe.

It is a FELONY to abuse or neglect an animal. I further understand that a FDAR representative may make a follow up visit, at a mutually convenient time, to ascertain that all conditions continue to be satisfied. If I fail to comply with the terms of this agreement, I will reimburse FDAR for any costs incurred by the organization to reclaim and remedy the breach of contract [lawsuits, etc.].

PLEASE initial each of the following conditions below to signify that you have read and agreed to each:

1. The dog will be housed at my home as a family pet, will sleep indoors at night and when home alone, and dog shall have access to the residence. WE PLACE DOGS AS FAMILY PETS ONLY.

2. I will keep a personalized ID tag with name and phone number on the pet AT ALL TIMES and dogs will be leashed and accompanied in public areas.

3. IF FOR ANY REASON I AM UNABLE TO KEEP OR PROVIDE ADEQUATE CARE FOR THIS PET, I AM OBLIGATED TO RETURN THIS ANIMAL TO FDAR.

4. I WILL WORK WITH FDAR IN FINDING A NEW HOME. I will foster for up to three [3] months while working with FDAR on finding a new home. I will not sell or give this pet to any other person, friend, relative, organization, medical laboratory, pound or animal shelter.

5. If I move to a new location, I will notify FDAR of my new address and phone number. FDAR MUST BE NOTIFIED IMMEDIATELY SHOULD THE PET BECOME LOST [also notify if deceased].
